- > Aadhaar Number: Identifies documents and transmissions that contain Aadhaar Numbers (UID).
- > Confidential Document: Identifies documents and transmissions that contain language in the header, footer or metadata indicating the conte use.
- > Encrypted Files (Predefined Policy): Identifies documents and transmissions containing encrypted or password-protected files,
- > INDIA IT Act (Predefined Policy): Detects Name and Aadhaar Numbers.
- > Network Security Information: Detects IP Address and network related keywords in PDF, word, Visio, Jpeg etc.
- > Software Design Documents: Detects software design related keywords such as design, architecture, user interface etc.
- > Software Source Code: Identifies documents and transmissions that contain source code and computer programs written in the C, C++, C#

We request your prompt response for event stated above to mask/remove Aadhaar Numbers (UID) at the earliest.
