ORDER:

As per the policy decision of the Government of India the benefits of the cash component as well as in-kind services of all welfare schemes such as Central Sector Schemes (CS), Centrally Sponsored Schemes (CSS) and also the State schemes should go to the individuals' bank accounts electronically, cutting down delays and diversions.

2. In order to implement Direct Benefit Transfer (DBT) effectively, DBT Mission, Cabinet Secretariat New Delhi has directed this UT Administration to constitute DBT Cell in the UT of Puducherry to take advantage of Information and Communications Technology(ITC) to improve Government to People interface, develop IT application to capture real time information about the DBT status of various programmes /schemes so that issues of efficiency, transparency and accountability are effectively achieved. Accordingly, a DBT Cell has been constituted in this UT of Puducherry for facilitating transition of the Schemes on the DBT platform with the following composition:

(i)	Director-Cum-Additional Secretary, Department of Civil supplies & Consumer Affairs, Puducherry.	: Chairperson
(ii)	Director, Planning & Research Department, Puducherry.	: Member
(iii)	Project Officer, DRDA, Puducherry	: Member
(iv)	Technical Director (DBT), NIC, Puducherry.	: Member
(v)	Programmer, Information & Technology Department, Puducherry.	: Member
(vi)	State Resource Person, UIDAI, Puducherry	: Member
(vii)	Deputy Director-Cum-Under Secretary, Department of Civil supplies & Consumer Affairs, Puducherry.	: Member Secretary

3. The DBT Cell would be responsible for coordinating efforts to develop IT applications for automation of process, direct payment to bank accounts, furnishing monthly report and also other reports to the DBT Mission New Delhi, as and when called for by them. The DBT Cell shall have a meeting whenever necessity arises.
