Dear Shri Parida,

As you are aware, the NITI Aayog has initiated an exercise to formulate vision and strategy for the period beyond the Twelfth Five Year Plan (which ends in March, 2017), under which the following inter-connected documents, with differing time horizons, are proposed to be prepared:

- (i) A vision document keeping in view the social goals set and/or proposed and Sustainable Development Goals (SDGs) for about 15 years i.e. up to 2030 which is co-terminus with the period to achieve the SDGs.
- (ii) A 7-year strategy from 2017-18 to 2023-24 to convert the long term vision into implementable policy and action as a part of "National Development Agenda" with a mid-term review after 3 years i.e. the year ending March, 2020.
- (iii) A 3-year Action document for 2017-18 to 2019-20 aligned to the predictability of financial resources during the 14<sup>th</sup> Finance Commission Award period. This is also to help translate into actions the goals of the government to be achieved by 2019.

To further promote Co-operative Federalism, NITI Aayog seeks your vision as to where you would like to see your UT and India in 2030. Your crisp and focused response would help NITI Aayog in formulation of the Vision Document for the country for the period up to end of 2030. Notably, the aforesaid vision formulation is envisaged to go beyond the traditional areas and also cover aspects of internal security/defence etc.

The Vice Chairman, NITI Aayog, had requested the Chief Minister of your State/UT vide his DO letter of even number dated 28<sup>th</sup> May, 2016 to enlighten NITI Aayog with his/her vision in this behalf by 15<sup>th</sup> June, 2016.

However, the requisite documents pertaining to your UT are still awaited in NITI Aayog. May I request you to expedite the preparation of the aforesaid documents, and forward the same to the NITI Aayog latest by 12<sup>th</sup> August, 2016 keeping view the extremely tight time-frame at our disposal for the purpose.

I would also request you to nominate an officer of the rank not below a Joint Secretary, preferably the one nominated/being nominated to handle SDGs, and forward his/her name, designation, and contact details (official mail ID, mobile, land line and fax numbers) to Shri Y.S.Malik, Special Secretary, NITI Aayog.
