## **ORDER**

The Lt. Governor, Puducherry is pleased to continue the engagement of Thiru R.Asokan, Deputy Director (Planning), (Retired), as CONSULTANT in the Planning and Research Department, Puducherry, for a further period of three (3) months (3<sup>rd</sup> Term) from 01.10.2023 to 31.12.2023 or till the necessity thereof ceases, whichever is earlier, with the fixed consultancy fee / remuneration of Rs.50,000/- (Rupees fifty thousand only), per month.

2. Thiru R.Asokan, Consultant of this Department is entrusted with the following works:
  - i. Department's Banking related subjects
  - ii. Arranging / attending State Level Banker's Committee Board (SLBC) Meeting of Puducherry Grama Bank
  - iii. Liaise with the General Manager of Non-Banking Financial Companies (NBFC) and RBI, Chennai for conducting State Level Co-ordination Committee meeting in Puducherry.
  - iv. Monitoring of CSS – Co-ordination with 34 Departments dealing 110 Schemes
  - v. Flagship Programmes consisting of 95 Schemes – Matters relating to MHA
  - vi. And all other departmental works as assigned by the Director(Plg).
3. The appointment /engagement of the Consultant is regulated with the following:
  - a. *The Consultant is eligible to avail 12 days Casual Leave in a calendar year on pro-rata basis.*
  - b. *The Consultant is entitled for Travelling Allowance on official tour at the rates applicable to Government Officer holding equivalent post on regular basis.*
  - c. *The Consultant is not entitled to any allowance such as Dearness Allowance, Residential Telephone, Transport Facility, Residential Accommodation, Personal Staff, Medical Reimbursement, Insurance etc.,*
