- The District Collectors should constitute teams of Lead District Managers (LDM's) of various commercial banks, under the overall supervision of SDMs and Associations of Tahsildars/BDPOs to undertake wide-spread awareness programmes and organise demonstrations for use of these methods of Digital payments.
- Direct local authorities along with LDMs to organise public interaction campaign and act as public interface in this regard.
- Demonstration via video/audio and to leverage technology in amplification of the Digital Payments campaign.
- Create awareness and usage of Digital payment practice so as to penetrate their usage at the grass root levels- Districts, Taluks and Panchayats.
