- 2. Coverage of Mandatory Biometric Update (MBU) for Aadhaar of residents crossing age of 5+ years and 15+ years
- 3. Strengthening of Aadhaar eco system-Document Update in Aadhaar issued 10 years ago and review of progress
- 4. Strengthening of Aadhaar eco system Restriction of new enrolment facility in selected district/block level Aadhaar centres.
- 5. Strengthening of Aadhaar Ecosystem State Government Portal for new enrollment (residents in the age group of more than 18 years)
- 6. Strengthening of Aadhaar Eco system Periodic meetings of District Level Aadhaar Monitoring Committee
- 7. Review of progress in availability of RD Devices at Aadhaar enrolment centers (AECs)
- 8. Providing Government space for opening of UIDAI Aadhaar Seva Kendra (ASK's) at District level and CSC e-Gov ASKs at Block/Taluk level
