The points discussed in the meeting are as follows:

Sl. No.	Subject	Action to be taken
1.	The time frame should be fixed to sort out the discrepancies in the beneficiary data of Welfare implementing Departments. Data already forwarded to the concerned department.	Time line should be prescribed by the concerned departments immediately
2.	MoU for Aadhar Data Vault to be completed	Director (Planning) to moot out the proposal for the approval of Development Commissioner
3.	A letter to UIDAI may also be addressed by the Competent Authority as a part of the Administrative Procedure to obtain permission for sharing of data.	Director (Planning) shall take necessary action
4.	Seeding of Aadhar numbers of Govt. Employees	DAT to take action to complete the same by the 1 st week of May 2022.
5.	To impart training to sensitize the welfare of implementing departments on UDH by NIC.	Schedule may be prepared by NIC and with concurrence of Development Commissioner -cum-Principal Secretary (Plg.) for further details be finalized.
