Review of MP/VIP/PMO References

Member of Parliament's Local Area Development Schemes

The Union Territory of Pondicherry consists of Four Regions viz. Pondicherry, Karaikal, Mahe and Yanam and it is being administrated by the Government of Pondicherry. The U.T of Pondicherry having one Member of Parliament of each in Rajya Sabha and Lok Sabha. This MPLAD Scheme is being implemented in Pondicherry through DRDA, Pondicherry as Nodal Agency. The District Collector is Chairman of DRDA and the Project Director, DRDA is the District Authority for MPLAD Schemes.

16th Lok Sabha

Thiru. R. Radhakrishnan has elected Hon'ble Member of Parliament of 16th Lok Sabha of UT of Puducherry. The Ministry of Statistics and Programme Implementation, New Delhi has released Rs.5.00 Crores for 1st and 2nd instalment for the year 2014-15. The Hon'ble M.P has recommended 49 works for the year 2014-15. Among them 42 works sanctioned at the cost of Rs.4.50 crore (14 works are progress, 28 works are Tender stage).

Rajya Sabha

Thiru. P. Kannan has nominated as Hon'ble Member of Parliament (Rajya Sabha) of UT of Pondicherry. The Ministry of Statistics and Programme Implementation, New Delhi has released so far Rs.5.50 crore for this scheme. As desired by the Hon'ble Prime Minister of India, the Hon'ble M.P has taken the work as pet project for "Construction of Toilet Block, Urinals, providing Napkin Incinerator and Installation of Water Purifier to the Various Government Colleges and Schools in U.T of Pondicherry for Rs.13.00 crore. The pet project works are going on priority basis in different stages (i.e 50% of progress, Tender and Estimate stages). So far the Hon'ble M.P has recommended 69 works. Out of which 60 works are sanctioned at the cost of Rs.10.43 crore (13 works completed, 16 works are in progress and 31 works are in Tender stage)

Status Report on SAGY:

Hon'ble Prime Minister has launched Saansad Adarsh Gram Yojana (SAGY) on 11th October, 2014. The main objective of the scheme to trigger process which lead to holistic developments of the identified Gram Panchayats and to substantially improve the standard of

living and quality of life of all sections of the population. Under this programme, each M.P. will take the responsibility of developing physical and intuitional infrastructure in three villages by 2019.

Under, the Saansad Adarsh Gram Yojana (SAGY) scheme, Rajya Sabha MP Shri. P. Kannan has identified the Sellipettu Gram Panchayat in Villianur Commune of Puducherry District and Lok Sabha MP Shri. R. Radhakrishnan has identified the Karaiyamputhur Gram Panchayat in Bahour Commune of Puducherry District.

Both MP's under their leadership conducting Awareness Campaign & various sensitization programmes in these identified Gram Panchayats. Also they coordinated all the "Swachh Bharat Campaigns" in the Gram Panchayats, which has been updated in the SAGY MIS.

According to the guidelines of the scheme, the Union Territory of Puducherry Government has formed two committees, one at State level and another at District Level. Both the Committee met and had an overview on the implementation of the scheme. Charged Officers for both identified Gram Panchayats have been appointed.

Baseline survey, which forms the initial stage of the programme have already been completed for both Panchayats. The uploading of Data entry of the survey information in the SAGY MIS is under progress.

There is a Empowered Committee to frame the Village Development Plan under the guidance of the District Collector, Puducherry has been formed. Academicians from various universities have been coordinated in this committee.

Sectoral Teams for Health, Education, Agriculture, Animal Husbandry, Sanitation, Skill developer comprising of Government Officials, local leaders Academicians and the public of the respective Panchayats have been formed to prepare Need Matrix for both the Gram Panchayats. Rural Appraisal through Resource Mapping & Social Mapping has been completed through people's participation.

Further, it has been envisaged by our government to prepare the Village Development Plan by second week of March, so that wherever fund gap arise necessary sanctions can be incorporated in the ensuing State Budget.

Govt. of India, Ministry of Rural Development has sanctioned an amount of Rs.1.00 lakh to this UT of Puducherry for meet out the miscellaneous activities of identified Gram Panchayats.

Pradhan Mantri Jan Dhan Yojana

Financial Inclusion

Financial Inclusion is the buzz word in all the forums and UT of Puducherry is the first State where Financial Inclusion project named Nation Pilot Project for Financial Inclusion was implemented in the year 2005. Financial services plan is being implemented in 67 villages of Union Territory. All these villages are being covered with banking services through Branches/Banking Service Centres/Ultra Small Branches/Business Correspondent Agents (BCA) etc.

Pradhan Mantri Jan Dhan Yojana (PMJDY), the National Mission on Financial Inclusion has an ambitious objective of covering all households in the country with banking facilities and having a bank account for each household and this lead an important for including people left-out into the mainstream of the financial system. This scheme was launched by the Hon'ble Chief Minister on 28th August 2014 in the U.T of Puducherry. More than 70000 accounts have been opened in various banks under PMJDY programme. So far banks have issued 45822 RuPay card to the accountholders under this scheme. The total number of SB account available as on September 2014 is placed at 495765. It is informed that all the households in the UT of Puducherry are having atleast one bank account in the family. Ministry of Finance, Govt. of India has informed in their press release on 2.10.2014 that UT of Puducherry has attained saturation under PMJDY. Hon'ble Prime Minister has also appreciated this UT administration for the tremendous achievement under this programme. As the financial services plan for Financial Inclusion villages already envisages financial literacy, providing credit facilities, micro insurance and micro pension schemes the same is extended to entire Union Territory under PMJDY. Banks are requested to provide more credit facilities to the account holders. All the branches are requested to conduct campaigns in the services area every month as per the guidelines of Reserve bank of India especially in Financial Inclusion villages.

Three Social Securities Schemes viz. Pradhan Mantri Suraksha Bima Yojana (PMSBY), Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY) and Atal Pension Yojana (APY) were launched in the UT of Puducherry at a function held on 09.05.2015 by Shri Snawar Lal Jat, Union Minister of State, M/o Water Resources, River Development and

Ganga Rejuvenation in the presence of Hon'ble Chief Minister, UT of Puducherry with Hon'ble Member of Parliament (Lok Sabha), Shri R. Radhakrishnan, Secretaries to Government, Executive Director of Indian Bank and representatives from various banks and insurance companies also attended the function. So far we have enrolled 1,00,056 beneficiaries for PMSBY, 37,002 beneficiaries for PMJJBY and 300 beneficiaries for APY.

Western Bye Pass Road (Phase-I) in Karaikal

Karaikal town is located on the National highway NH 45 A connecting villupuram and Nagapattinam. This road provides the main connectivity to the capital of Puducherry and Karaikal. Most of the pilgrims are required to pass through Karaikal twon for visiting pilgrimage centres of Thirunallaru, Nagore and Velankanni.

In order to ease the traffic congestion in the roads of Karaikal town and to provide smooth and hassle free travel and transport on the roads, the schemes for bye pass road on the Western side of Karaikal twon has been formulated.

The total length of Western bye pass road is 8.20 km starting at Thalatheru on the Western side on NH 45 A and runs through the villages of Thalatheru, Koilpathu, Dharmapuram, Puduthurai, Melaoduthurai, Akkaravattam, Neravy village and ends at the new bridge cross Thirumalairajanar in TR Pattinam village.

For the formation of Western Bye pass road, lands to an extent of 34 AH, 78A, 49CA have been acquired. The Western Bye pass is proposed to be laid in two phases. The first phase starts at NH 45 A near Thalatheru village at Ch.0/00 km to Ch.2/980 km in Thirunallar road near Kalayankatti bridge crossing over the newly constructed bridge across river Vanjiar.

Report on MAKE IN INDIA

EASE OF DOING BUSINESS

The Prime Minister of India, in the month of September 2014 launched 'Make in India', a major national initiative which focuses on making India a global manufacturing hub.

Key thrust of the programme would be on cutting down in delays in manufacturing projects clearance, develop adequate infrastructure and make it easier for companies to do business in India.

Ministry of Commerce and Industry, Government of India, has identified 98 action points to take action on with timelines to make the mission of Ease of Doing Business wholesome and effective. As they relate to action taken / to be taken by various departments all the concerned departments in Puducherry have been directed to complete the action advised by the Ministry

Out of the 98 points listed for action, we have already implemented 47 points. 46 are under process and 5 require amendment in legislations for which central and state governments are being moved.

It is also pertinent to mention that this administration has already put in place a mechanism — a single point contact system — for the entrepreneurs. The system, identified as Industrial Guidance Bureau (IGB), acts as a facilitator for entrepreneurs to obtain clearances from departments / agencies in a time bound manner for the setting up of industrial establishments. Common application form has been developed for the purpose and timelines are also fixed for departments to decide on the applications.

Officials from departments concerned meet every week and guide entrepreneurs on the process of obtaining clearances. A committee constituted as a part of the IGB, periodically

reviews the status of the applications and also empowered to decide on them. Besides, it also suggests procedural reforms to remove bottlenecks in setting up of industrial units. It continuously strives to improve the processing mechanism of applications. Electronic means has also been put in place for online processing of the applications.

Efforts are being taken, as the action points intend, to dovetail and provide all possible services for doing business through a single comprehensive platform.

A reply on the status of the action points as presented above has been submitted to the Cabinet Secretary and Secretary, Department of Industrial Promotion & Policy, Ministry of Commerce & Industry, Government of India.

In view of the increased demand for land for setting up Industries and to arrest sporadic displacement of Industries, it is proposed to set up two more new Industrial Estates at Sedarapet / Karasur and Mettupalayam. Large scale Industries and Industries which provide more employment would be attracted by giving allotment of required land in the Industrial estates. Action has already been taken to attract investors, "Puducherry a Preferred Industrial Investment Destination", by way of ensuring timely and hassle free guidance / clearance to entrepreneurs. Required land for setting up of industries is also available with Government. Investors both from India and overseas would be invited and a 'Mega Investors Meet' would be conducted.

SKILL DEVELOPMENT - Tool Room cum Technology Development Centre

Government of India is currently doing mapping for assessing skill manpower demand for specific sectors and synchronising between industry and job seekers for ensuring that industry specific skills are imparted.

In order to improve the technological knowledge, a state of art Tool Room cum Technology Development Centre will be setup by the Ministry of MSME, Government India at Pillaichavady, Kalapet, Puducherry. The foundation stone was laid on 22/02/2014. The GOP vide GO Ms. No. 35, dated 03/10/2014 has transferred 10 acres of land at Pillaichavady (adjacent to Pondicherry Engineering College), Puducherry, to the Ministry of MSME, GOI and handed over the possession of the land on 10/12/2014.

The cost of the project will be about Rs. 250 crores. The tool room will have state of art infrastructure facilities and business processes including latest machinery & equipment to design and manufacture quality tools, testing facility and for conducting training facilities programmes confirming to international standards. This centre will also impart skill

development training to unskilled school dropouts and up to graduate engineers level so as to make them employable. This centre will impart training to 5000 persons during first year and reach about 25,000 persons per annum within 5 years.

The team consisting of Consultants from Ministry of MSME and a member from World Bank, officials of MSMED Institute, Industries Department and Education Department visited the site to assess the social effectiveness of the location.

Western Bye Pass Road (Phase-I) in Karaikal

Karaikal town is located on the National highway NH 45 A connecting villupuram and Nagapattinam. This road provides the main connectivity to the capital of Puducherry and Karaikal. Most of the pilgrims are required to pass through Karaikal twon for visiting pilgrimage centres of Thirunallaru, Nagore and Velankanni.

In order to ease the traffic congestion in the roads of Karaikal town and to provide smooth and hassle free travel and transport on the roads, the schemes for bye pass road on the Western side of Karaikal twon has been formulated.

The total length of Western bye pass road is 8.20 km starting at Thalatheru on the Western side on NH 45 A and runs through the villages of Thalatheru, Koilpathu, Dharmapuram, Puduthurai, Melaoduthurai, Akkaravattam, Neravy village and ends at the new bridge cross Thirumalairajanar in TR Pattinam village.

For the formation of Western Bye pass road, lands to an extent of 34 AH, 78A, 49CA have been acquired. The Western Bye pass is proposed to be laid in two phases. The first phase starts at NH 45 A near Thalatheru village at Ch.0/00 km to Ch.2/980 km in Thirunallar road near Kalayankatti bridge crossing over the newly constructed bridge across river Vanjiar.

Report on MAKE IN INDIA

EASE OF DOING BUSINESS

The Prime Minister of India, in the month of September 2014 launched 'Make in India', a major national initiative which focuses on making India a global manufacturing hub.

Key thrust of the programme would be on cutting down in delays in manufacturing projects clearance, develop adequate infrastructure and make it easier for companies to do business in India.

Ministry of Commerce and Industry, Government of India, has identified 98 action points to take action on with timelines to make the mission of Ease of Doing Business wholesome and effective. As they relate to action taken / to be taken by various departments all the concerned departments in Puducherry have been directed to complete the action advised by the Ministry

Out of the 98 points listed for action, we have already implemented 47 points. 46 are under process and 5 require amendment in legislations for which central and state governments are being moved.

It is also pertinent to mention that this administration has already put in place a mechanism — a single point contact system — for the entrepreneurs. The system, identified as Industrial Guidance Bureau (IGB), acts as a facilitator for entrepreneurs to obtain clearances from departments / agencies in a time bound manner for the setting up of industrial establishments. Common application form has been developed for the purpose and timelines are also fixed for departments to decide on the applications.

Officials from departments concerned meet every week and guide entrepreneurs on the process of obtaining clearances. A committee constituted as a part of the IGB, periodically

reviews the status of the applications and also empowered to decide on them. Besides, it also suggests procedural reforms to remove bottlenecks in setting up of industrial units. It continuously strives to improve the processing mechanism of applications. Electronic means has also been put in place for online processing of the applications.

Efforts are being taken, as the action points intend, to dovetail and provide all possible services for doing business through a single comprehensive platform.

A reply on the status of the action points as presented above has been submitted to the Cabinet Secretary and Secretary, Department of Industrial Promotion & Policy, Ministry of Commerce & Industry, Government of India.

In view of the increased demand for land for setting up Industries and to arrest sporadic displacement of Industries, it is proposed to set up two more new Industrial Estates at Sedarapet / Karasur and Mettupalayam. Large scale Industries and Industries which provide more employment would be attracted by giving allotment of required land in the Industrial estates. Action has already been taken to attract investors, "Puducherry a Preferred Industrial Investment Destination", by way of ensuring timely and hassle free guidance / clearance to entrepreneurs. Required land for setting up of industries is also available with Government. Investors both from India and overseas would be invited and a 'Mega Investors Meet' would be conducted.

SKILL DEVELOPMENT - Tool Room cum Technology Development Centre

Government of India is currently doing mapping for assessing skill manpower demand for specific sectors and synchronising between industry and job seekers for ensuring that industry specific skills are imparted.

In order to improve the technological knowledge, a state of art Tool Room cum Technology Development Centre will be setup by the Ministry of MSME, Government India at Pillaichavady, Kalapet, Puducherry. The foundation stone was laid on 22/02/2014. The GOP vide GO Ms. No. 35, dated 03/10/2014 has transferred 10 acres of land at Pillaichavady (adjacent to Pondicherry Engineering College), Puducherry, to the Ministry of MSME, GOI and handed over the possession of the land on 10/12/2014.

The cost of the project will be about Rs. 250 crores. The tool room will have state of art infrastructure facilities and business processes including latest machinery & equipment to design and manufacture quality tools, testing facility and for conducting training facilities programmes confirming to international standards. This centre will also impart skill

development training to unskilled school dropouts and up to graduate engineers level so as to make them employable. This centre will impart training to 5000 persons during first year and reach about 25,000 persons per annum within 5 years.

The Government of India, Ministry of Power has approved for the implementation of Smart Grid Pilot Project in Puducherry at an estimated amount of Rs,46.11 Crs. Ut of which the Ministry of Power to finance 50% of cost i.e. Rs.23.055 Crs. And the remaining 50% is to be arranged by the department

For the Utility share of 50% the department has floated tender on 18.06.2015 for finding suitable investor for establishment of SGPP for 34000 consumers of Twon-I area of Division-I and 1640 LT CT operated consumers in all the four regions of Pondicherry on revenue sharing basis by investment made by the bidder.

It is planned to develop a consumer utility interactive Pilot Smart Grid which will cover smart metering & control through Advanced Metering Infrastructure (AMI), Power Quality Management (PQM), Peak Load Management etc., in the Pondicherry Urban Distribution Division of the Electricity Department. The final date of submission of e-Tender is extended upto 12.08.2015 due to request from bidders.

Initiatives in Renewable Energy Generation

The department has provided grid connectivity to six numbers of such rooftop solar PV power projects with total aggregating capacity of 96 KW with net metering arrangement. It is expected that in near future the proliferation of such type of projects in the UT would be manifold, as lot of awareness is being created among the public on the benefits of these projects.

Demand Side Management Initiatives

Under the DSM measures, the Electricity Department has implemented the DSM based efficient lighting program (DELP) in the entire UT of Puducherry with the technical and financial support of M/s EESL under ESCO model. The objective of this program is to replace the less energy efficient GLS lamp with that of more energy efficient LED lamps in the house hold sector. Under this program around 6,00,000 LED bulbs have been put into service in the place of equal number of GLS lamps, resulting in estimated energy saving of around 40 million units per annum.

DBT under National Food Security Act. 2013

According to the National Food Security Act. 2013 (NFSA) every person belonging to priority households, shall be entitled to receive 5 Kg. of foodgrains per person per month at subsidized prices. Providing that the households covered under Antyodaya Anna Yojana shall be entitled to 35 kg of foodgrains per household per month at the prices specified.

To implement the NFSA in the UT of Puducherry, the Government has decided to consider all the BPL ration cardholders as priority households. To include more households under the said act, additional priority households were identified and their ration cards were converted into BPL ration cards.

As of now 1,84,471 ration cards (28855 AAY + 155616 BPL ration cards) consisting 5,42,148 beneficiaries are identified.

The UT of Puducherry is opted go for unconditional DBT i.e cash for food with regard to implementation of NFSA. Accordingly the cash subsidy will be directly credited in the bank of account of the card holder through PFMS. To give the cash subsidy the Aadhaar and Aadhaar linked bank account of the beneficiaries are needed. The Department of Civil Supplies and Consumer Affairs has taken all the possible measures to seed the Aadhaar and Aadhaar linked bank account details of the NFSA beneficiaries. The details were pushed to PFMS for validation. As such 1,36,775 ration cards (17916 AAY + 118859 BPL) become eligible for DBT.

According to the National Food Security Act, a person of 14 years of age and above is beneficiary. As such each beneficiary of the BPL ration card is eligible for Rs.115.60 in lieu 5 Kg. of rice @ Rs.23.125 per kg. The subsidy amount has been calculated accordingly and the amount is deposited in the Aadhaar linked bank account holder of the respective ration card. The Government of India has provided Rs.5,67,33,961/- towards 1,36,775 ration cards.

Tool Room cum Technology Development Centre

Government of India is currently doing mapping for assessing skill manpower demand for specific sectors and synchronizing between industry and job seekers for ensuring that industry specific skills are imparted.

In order to improve the technological knowledge, a state of art Tool Room cum Technology Development Centre will be setup by the Ministry of MSME, Government India at Pillaichavady, Kalapet, Puducherry. The foundation stone was laid on 22/02/2014. The GOP vide GO Ms. No. 35, dated 03/10/2014 has transferred 10 acres of land at Pillaichavady

(adjacent to Pondicherry Engineering College), Puducherry, to the Ministry of MSME, GOI and handed over the possession of the land on 10/12/2014.

The cost of the project will be about Rs. 250 crore. The tool room will have state of art infrastructure facilities and business processes including latest machinery & equipment to design and manufacture quality tools, testing facility and for conducting training facilities programmes confirming to international standards. This centre will also impart skill development training to unskilled school dropouts and up to graduate engineers level so as to make them employable. This centre will impart training to 5000 persons during first year and reach about 25,000 persons per annum within 5 years.

The team consisting of Consultants from Ministry of MSME and a member from World Bank, officials of MSMED Institute, Industries Department and Education Department visited the site to assess the social effectiveness of the location. It is proposed to conduct a workshop in connection with preparation of DPR on this project with Industrial Associations / Industrialists on 11/9/2015 by the team of World Bank and officers of Ministry of MSME, Government of India.

Out of the overall lengh of 65 Kms of pipeline 62 kms falls under Government of Andhra Pradesh territory for which issuance several permissions and removal of encroachments were involved. The land for construction of pump house and the land along which the pipeline has to be laid belongs to the Government of Andhra Pradesh for which as per the agreement executed between Govt. of Andhra Pradesh and Govt. of Puducherry on 25.03.2013, a land lease agreement to be executed with irrigation Department, AP and PWD, Puducherry. As such an amount of Rs.35.85 Lakhs was paid on 25-6-2014 for executing the land lease agreement on 10-1-2015 between Irrigation Department, A.P. and P.W.D., Puducherry. After the execution of the this agreement final alignment of pipe line from pump house to the downstream of barrage and crossing of left canal was approved by the Chief Engineer, Irrigation Department, A.P on 25th May 2015.

For getting power supply to the pump house at Dowlaiswaram an agreement between Eastern Power Distribution Company of Andhra Pradesh and P.W.D., Puducherry was executed on 8-10-2014 for the supply of 33 K.V. H.T power after payment of Rs.44,62,830/- for laying of required transmission lines at our pump house location. The power supply line work is in progress. Since electrical power supply was not extended to the pump house by Eastern Power Distribution Company of A.P the pumping system is now running with Generator power.

Report on MAKE IN INDIA - Ease of doing Business

The Prime Minister of India, in the month of September 2014 launched 'Make in India', a major national initiative which focuses on making India a global manufacturing hub.

Key thrust of the programme would be on cutting down in delays in manufacturing projects clearance, develop adequate infrastructure and make it easier for companies to do business in India.

Ministry of Commerce and Industry, Government of India, has identified 98 action points to take action on with timelines to make the mission of Ease of Doing Business wholesome and

effective. As they relate to action taken / to be taken by various departments all the concerned departments in Puducherry have been directed to complete the action advised by the Ministry

Out of the 98 points listed for action, we have already implemented 47 points. 46 are under process and 5 require amendment in legislations for which central and state governments are being moved.

Elaborating on the 98 action points, DIPP prepared an assessment framework with questionnaire for the purpose of a survey to rank the states on EODB. The framework covered 285 questions across various key areas pertaining to various Departments. This office collected details from the Departments and responded to the questionnaire online.

As a follow up, a study team representing DIPP visited on 24 th July 2015 to asses state level reforms for EODB. This office coordinated with all Department concerned for the assessment.

It is also pertinent to mention that this administration has already put in place a mechanism – a single point contact system – for the entrepreneurs. The system, identified as Industrial Guidance Bureau (IGB), acts as a facilitator for entrepreneurs to obtain clearances from departments / agencies in a time bound manner for the setting up of industrial establishments. Common application form has been developed for the purpose and timelines are also fixed for departments to decide on the applications.

Officials from departments concerned meet every week and guide entrepreneurs on the process of obtaining clearances. A committee constituted as a part of the IGB, periodically reviews the status of the applications and also empowered to decide on them. Besides, it also suggests procedural reforms to remove bottlenecks in setting up of industrial units. It continuously strives to improve the processing mechanism of applications. Electronic means has also been put in place for online processing of the applications.

Efforts are being taken, as the action points intend, to dovetail and provide all possible services for doing business through a single comprehensive platform.

A reply on the status of the action points as presented above has been submitted to the Cabinet Secretary and Secretary, Department of Industrial Promotion & Policy, Ministry of Commerce & Industry, Government of India.

In view of the increased demand for land for setting up Industries and to arrest sporadic displacement of Industries, it is proposed to set up two more new Industrial Estates at Sedarapet / Karasur and Mettupalayam. Large scale Industries and Industries which provide more employment would be attracted by giving allotment of required land in the Industrial estates. Action has already been taken to attract investors, "Puducherry a Preferred Industrial Investment Destination", by way of ensuring timely and hassle free guidance / clearance to entrepreneurs. Required land for setting up of industries is also available with Government. Investors both from India and overseas would be invited and a 'Mega Investors Meet' would be conducted.

Agriculture

The Department of Agriculture has conducted pre-season training camps for samba season, paddy cultivation and pre-season training camps for horticultural crops during the months of July & August 2015. The Pre-season training camps for educating the farmers on samba, paddy cultivation was conducted in various villages of Puducherry region.

The latest technologies for paddy cultivation for boosting the production of paddy during the samba season 2015 were delivered during the pre-season campaign 2015. Topics on Soil Health Management and Organic farming system in paddy, integrated pest management techniques, system of rice intensification were the major areas covered during the training camps. Scientists from various Agricultural Research Stations participated in the training camps and delivered lectures to the farmers.

Similarly, a pre-season training camp was organised by the Horticultural wing of the Department and training programmes were conducted in various villages for transfer of technology related to Aadipattam vegetable crops cultivation and also scientific methods of cultivation techniques for other horticultural crops.

Civil Supplies

DBT under National Food Security Act. 2013

According to the National Food Security Act, a person of 14 years of age and above is beneficiary. As such each beneficiary of the BPL ration card is eligible for Rs.115.60 in lieu 5 Kg. of rice @ Rs.23.125 per kg. The subsidy amount has been calculated accordingly and the amount is deposited in the Aadhaar linked bank account holder of the respective ration card. The Government of India has provided Rs.5,67,33,961/- towards 1,36,775 ration cards.

The UT of Puducherry is opted go for unconditional DBT i.e cash for food with regard to implementation of NFSA. Accordingly the cash subsidy will be directly credited in the bank of account of the card holder through PFMS. To give the cash subsidy the Aadhaar and Aadhaar linked bank account of the beneficiaries are needed. The Department of Civil Supplies and Consumer Affairs has taken all the possible measures to seed the Aadhaar and Aadhaar linked bank account details of the NFSA beneficiaries. The details were pushed to PFMS for validation. As such 1,36,775 ration cards (17916 AAY + 118859 BPL) become eligible for DBT

As of now 1,84,471 ration cards (28855 AAY + 155616 BPL ration cards) consisting 5,42,148 beneficiaries are identified.

According to the National Food Security Act. 2013 (NFSA) every person belonging to priority households, shall be entitled to receive 5 Kg. of foodgrains per person per month at subsidized prices. Providing that the households covered under Antyodaya Anna Yojana shall be entitled to 35 kg of foodgrains per household per month at the prices specified.

To implement the NFSA in the UT of Puducherry, the Government has decided to consider all the BPL ration cardholders as priority households. To include more households under the said act, additional priority households were identified and their ration cards were converted into BPL ration cards.

Transport

The Puducherry Road Transport Corporation (PRTC) is inducting 40 new buses into its fleet and plans to run the vehicles primarily on rural routes. 20 standard and 20 mini-buses are being provisioned under the Jawaharlal Nehru National Urban Renewal Mission (JNNURM).



The JNNURM Scheme-I (2009) involved acquisition of 40 buses. The PRTC has also been giving a high-tech makeover to its newer buses by adopting Intelligent Transport Systems (ITS) for features such as passenger information system, CCTV and e-ticketing, besides GPRS (general packet radio services) and GPS (global positioning system). The design and specifications of the 20 Tata Starbus standard semi-low-floor buses and an equal number of mini-buses — which will run on narrow routes and difficult terrain of the hinterland routes — were earlier approved by the Central Institute of Road Transport, Pune, under the Ministry of Shipping and Transport. "We have taken delivery of most of the new buses, including 17 of the 20 standard buses, and hope to acquire the remaining vehicles shortly,"

Higher & Technical Education

Up gradation of existing autonomous colleges to Universities

The appraisal of the Project Approval Board (PAB) of Rastriya Uchchatar Shiksha Abhiyan (RUSA) granted the up gradation of existing autonomous colleges to universities, the proposal of this UT Administration through the Technical Sub Group (TSG) recommendation. The PAB approved funding of a total Rs.77 crore for 2 components to the UT of Puducherry for the remaining Plan Period.

Social Welfare

Opening of Separate Department for the Welfare of Backward Class people and minorities

As announced in the Budget Speech 2015-16, separate Department of Directorate for the Welfare of Backward Classes and Minorities was opened for the welfare of Backward Class people and minorities. Consequent upon the starting of this Department, all the beneficiaries coming under the preview of Backward Classes and Minorities will get the benefits easily without any difficulties.



Public Works Department

With Central Government assistance under "Babuji Jagjivan Ram Chhatrawas Yajana " scheme in construction of boys hostels for Scheduled Castes students at Keezhakasakkudy, Karaikal for accommodating 44 students is taken up for execution at a cost of Rs.2.50 crore and the work is completed.



Power

The 110/22 KV Villianur Sub-station is the oldest sub-station in the UT of Puducherry. There are at present three nos. of 10 MVA Power Transformers with a station capacity of 30 MVA. The Sub-station, which was in operation under the control of the Tamil Nadu Electricity Board, was taken over by the Electricity Department on 28.10.2004. The Renovation and Modernisation of the Sub-station works such as 110 KV and 22 KV Switchyard and other equipments, Control room building, have been taken up at an estimated cost of Rs.6.26 Crore. The first phase of the works comprising of 110 KV Bays and associated LV bays along with new control room with new Control and Relay panels have been completed on 20.4.2015. The work has been executed by the Power Grid Corporation of India Limited.

In order to improve the reliability and augmentation of the capacity of 110 KV Feeder from Bahour 230 KV Sub-station to Eripakkam 110 KV Sub-station, erection of an additional circuit of 110 KV line has been sanctioned at a cost of Rs.1.38 Crore. The first phase of the work involving stringing of 2nd circuit with panther conductor for 20 spans out of 62 spans has been completed.

In order to meet the load growth and also to improve the voltage regulation, thereby reducing the line losses, 57 Nos. of new Distribution Transformers of various capacities have been commissioned and capacity of the existing 11 Nos. of Distribution Transformers has been enhanced.

Health Department

Dengue Awareness drive through street Plays, Publicity vans.

Directorate of Health and Family Welfare Services has planned to cover areas under 27 Primary Health Centres and 2 Community Health Centres through its publicity vans and street plays on mosquito borne diseases, especially dengue. The 15-day public awareness

drive began on 20th November 2015. The public are given questionnaires on diseases at the end of the street play. A control room for dengue has been set up in the office of the National Vector Borne Disease Control Programme (NVBDCP). 350 Domestic Breeding Checkers have been deployed to conduct house to house area-wise inspection visits on a 100-day programme.

The same was done in the month of November 2015 starting from 7th and continued for 7 consecutive working days. Planning for the same including the activities like Micro Planning, Training of Medical Officers and Para Medical Staffs, IEC and awareness generation to track down the "Drop Out" and "Left Out Children" in both districts was organized successfully and was implemented in both districts by the office of the Deputy Director (Immunization). A total of 304 children in first round and 103 in second round were covered.

Each and every child of both Puducherry and other states was tracked and immunized by the field workers and the report was sent on daily basis to Ministry of Health and Family Welfare, Govt. of India ensuring full coverage. This was to ensure the objective of achieving 100% coverage and thereby leaving no child was unimmunized in the UT of Puducherry.

Apart from cardiac surgeries, the latest technologies in cardiovascular medicine, including tissue engineering, 3D printing and stem cell therapy, will be made available to patients at the Indira Gandhi Government General Hospital and Post Graduate Institute here after the Puducherry government on 10.12.2015 signed a Memorandum of Understanding with the Frontier Lifeline Hospital, Chennai.

The MoU was signed by Dr. K.M. Cherian, CEO and Chairman of the Frontier Lifeline Hospital and K.V. Raman, Director, Health and Family Welfare Services, in the presence of Hon'ble Chief Minister N. Rangasamy, Chief Secretary Manoj Parida and Health Secretary V. Candavelou.

A team of doctors from Frontier Lifeline Hospital to perform cardiac surgeries at IGGGH&PGI thrice a week, and up to five surgeries a week, and provision of postoperative care. The treatment cost would be borne by the Puducherry government. Thus far, the government had been disbursing funds of up to Rs. 2 lakh per poor patient for cardiac surgeries. This will reduce cost for the Government, and for the patients who have to spend on lodging and also travelling to Chennai. The facility would eventually be extended to the Indira Gandhi Medical College and Research Institute.

The partnership allows for cardiac care for patients from Puducherry, Karaikal, Mahe and Yanam.

This will not just be bypass surgeries and open heart surgeries. It will include all latest technologies

in cardiac care like tissue engineering, 3D printing and stem cell therapy of which the Frontier Lifeline Hospital is a pioneer in India. We will be sharing this technology with Puducherry. Training would be provided not only to the doctors at IGGGH&PGI, but also the nurses and medical staff and would include specialist training.

LOCAL ADMINISTRATION DEPARTMENT

Govt. submits 'Smart City Proposal'

The proposed smart city would be developed as a 'Green Field' project in Karasur - Sedarapet region which falls within the Puducherry Planning Area, along with two pan-city initiatives of City Surveillance and public safety and Smart Solid Waste Management. The estimated cost of the Smart City proposal is around Rs. 5,661 crores.

HIGHER & TECHNICAL EDUCATION DEPARTMENT

Financial assistance to the tune of Rs.13.43 crore to students who were admitted to professional colleges through the Centralised Admission Committee (CENTAC) to the representatives of private medical and engineering colleges in the U.T. Puducherry.

Government of Puducherry had released Rs.40 crore under the Perunthalaivar Kamarajar financial assistance scheme for 2015-16. A sum of Rs.3.59 crore in respect of 1440 engineering students was disbursed directly to 12 engineering colleges. Similarly Rs.9.84 crore in respect of 439 MBBS students was paid directly to seven medical colleges in the

Union Territory. This scheme is implemented without interruption to ensure that no meritorious student is deprived of access to higher education due to financial constraints.

During the year 2015-16, a sum of Rs.39.99 crore was disbursed under the scheme to 7426 students including 6345 engineering students.

Under the Perunthalaivar Kamarajar financial scheme all MBBS students selected through CENTAC are given a financial assistance of Rs.2.25 lakh per annum. Similarly engineering students are given financial assistance of Rs.25,000 per annum.

ELECTRICITY DEPARTMENT

In order to meet the future increasing demand of power in the Union Territory of Puducherry this department has successfully signed a Power Purchase Agreement with Central Generating Station i.e. Neyveli Lignite Corporation (NLC) on 22.12.2015 for the power to be availed from the proposed Thermal Station – II (2nd Expansion) (2 X 500MW).

To achieve the targeted Renewable Power Purchase Obligation (RPO), it is proposed to avail 20 MW Solar Power for the Union Territory of Puducherry from the proposed Solar Power Plant at Neyveli.

The Smart Grid Pilot Project under the National Smart Grid Mission of Govt. of India is back on track with the Puducherry Government finalizing the Chinese firm Ms. Dong Fong Electronics Limited, as the investors cum service provider through tenders for the project. The firm will be implementing the project on investors model and the installation of smart meters is expected to commence from 2016. The total cost of the project is Rs. 43.61 crores and the Central Government will fund 50% of project cost. The project shall initially cover 34,000 services in the bouleward region and it will be subsequently extended in the remaining part of the city. Ms. Dong Fong Electronics Limited, will fund the remaining 50% of the project cost. The installation of Advanced meters would help consumers to monitor real time power consumption and billing and could manage power usage. On the department side, the online energy usage pattern, detection of mal practices, billing and collection etc., could be ensured. The first phase of the project will go on stream in 2017 in boulward area and it will be later rolled out across the city.

And the first floor area is 354.90 sqm. Facilities have been made for the public to deal the registration of their vehicle in the office room having a carpet area of 95.00 sqm which including on cash counter. The building also consit of Regional Transport Officer room, Motor vehicle Inspectors Rooms, PA Room, Computer Room and toilet block in ground floor and training hall, record room and meeting hall in the first floor. Separate block for leaner's license and High Security Registration plate have been constructed.

Public Works Department

The New Indoor Stadium at Keezhaveli, Karaikal was inaugurated by the Hon'ble Chief Minister on 29th January 2016 with the total cost of 13.22 crore.

The Indoor Stadium was constructed with a plinth area of 4600.00 sqm. The total seating capacity of the Indoor Statium is 1500 Nos. The size of play ground is 38m x 34m made up of "Maple Wood" flooring on par with international standards.

In the combined sports complex, Karaikal, Government sanction has been obtained for Rs.8.89 crore through HUDCO finance Assistance. The Work order has been issued by the PWD to take up the work. The Hon'ble Chief Minister to lay foundation stone for all the above works on 29.01.2016 and the work will be taken up by PWD and complete during the financial year 2016-2017.

Construction of approaches to Road Over Bridge at Km 33/000 on NH 45A in the Union Territory of Puducherry at a cost of ₹24.45 crores. The Railway portion has been completed by the Southern Railway. For the approach portion foundation stone is laid by the Hon'ble Central Minister on 13.01.2016. The work will be completed in 24 months.

Construction of Civil Station at Bharathiyar Palkalaikoodam in Ariyankuppam, Puducherry is proposed at a cost of ₹ 7.00 Crore. The proposed civil station is to be accommodate various Government Departments viz., PWD, Electricity, Revenue, BDO, Women and Child Welfare, Education and etc., so that service of the Department will reach to the public in their vicinity under single umbrella. The work will be completed 14 months.

Fisheries and Fishermen Welfare Department

Fish market maintenance given to Oulgaret Municipality

Hon'ble Chief Minister N. Rangasamy on Wednesday formally handed over maintenance of the Modern Hygienic Fish Market located on the East Coast Road (ECR) to the Oulgaret Municipality.

The building had remained locked for the last one-and-a-half years due to procedural delays between the Fisheries department and the Oulgaret municipality over the mechanism for allotment of stalls to vendors and the norms for selection of vendors.

The two-storey fully air-conditioned structure spread over 37,886 square feet was built by the Project Implementation Agency (PIA) with World Bank assistance of Rs.13.5 crore under the Tsunami Emergency Rehabilitation Project

According to an official in the Fisheries department, the new complex was planned to cater to the needs of fishermen from several coastal villages in Puducherry.

The complex has around 110 air-conditioned stalls including 55 stalls on the ground floor with cold storage facilities.

While the first floor of the market would sell low-cost fish, the second floor would have costly varieties for sale. Provisions have been given for lifts. A separate area has been ear marked for processing and cutting the fish. Since the complex is big, fishermen from several coastal villages can sell their catch, the official added.

The other facilities in the complex include an effluent treatment plant, auction hall for fishes, 10-tonne capacity ice plant and an ATM. The plant would treat effluents collected from the market and has been fitted with a 10-KV solar power plant to meet the requirements of the shopping area.

The Fisheries department will finalise the list of vendors and hand it to the municipality for allotment of stalls. The facility will be opened for public use shortly, an official said. Local Administration Minister N.G. Pannirselvam and officials from PIA were present.

The fully air-conditioned building was built by Project Implementation Agency.

Electricity Department

In order to create awareness of using LED lamps among the general public, Renewable Energy Agency of Puducherry (REAP) has initiated second phase of distribution of LED lamps.



Electricity Minister T. Thiagarajan launched the second phase of distribution of LED bulbs in three villages recently.

Electricity Minister T. Thiagarajan on Wednesday launched the second phase of distribution of LED bulbs in three villages- Irulanchandai, Kuruvinatham Pet, Bahour Pet- of Bahour commune.

The minister also inaugurated the "LED Village Campaign program" at Pudhu Nagar, Kanniyakovil. This program includes distribution and replacement of existing high power consuming sodium vapour lamp (SVL)/ Fluorescent lamp (FTL) with LED Street lights. LED Village Campaign Programme, the energy conservation scheme is supported by Bureau of Energy Efficiency (BEE), Union Ministry of Power.

The objectives of this scheme is to replace the existing incandescent bulbs in the One House One Bulb (OHOB) households into LED Bulbs and the existing power-consuming street lights with LED street lights in the selected villages. Under this LED Village Campaign Programme, 1850 number incandescent bulbs have been replaced with LED bulbs and 166 number of Sodium vapour lamp (SVL)/ Fluorescent lamp (FTL) have been replaced with Energy Efficient LED Street Lights.

The project is funded by Bureau of Energy Efficiency (BEE), New Delhi, Govt. of India with the project cost of Rs.15.98 lakh. By employing this project, almost 85 per cent of power can be conserved from the total power usage by the conventional type lamps, said a press release from the Renewable Agency Puducherry.

Health Department

Puducherry is a non-endemic area for Dengue, Malaria etc., A limited out of Chikungunya was effectively controlled. Puducherry and Karaikal are now in the process of being declare of non endemic region of filarial. Puducherry has placed in the third place after Goa and Tamil Nadu in the eradication of lymphatic Filarilarial diseases. This has been made possible due to effective implementation of Mass Drug Administration for control of Filariasis. Intensive action is also being taken on the affected places identified through GPRA method.

The Indira Gandhi Govt. General Hospital and PG Institute, Puducherry has achieved the milestone of performing 1000 cases of Coronary Angioplasty (a procedure to widen narrowed or obstructed arteries or veins) from the data of inception (i.e 27/06/2007) to 05.01.2016 in the Cath Lab of the Hospital.

Bharathiar Memorial Museum-cum-Research Centre

Renovation of Bharathiar Memorial Museum and reconstruction of adjacent building for an amount of Rs.99,68,100/- and opened for the public on 05.02.2016.

Mahakavi Bharathiar Memorial building at Easwaran Koil Street, Puducherry was acquired by the Government of Puducherry in the year 1972 and the Memorial was opened to the Public since October 2009, the house remains closed due to the dilapidated condition of the building. The adjacent building which was also acquired for the Museum was also in most dilapidated condition. The building was renovated by the M/s INTACH, Puducherry and opened to the Public.

Opening of Rural Godowns & Open Auction Yard at Karaikal

Newly constructed two numbers of Rural Godowns and one number of Open Auction Yard by the Public Works Department, Karaikal in the premises of Karaikal Market Committee was inaugurated on 07.02.2016 by Hon'ble Chief Minister.



The capacity of the each Godown is 500 Metric Ton and the Open Auction Yard is 100 Metric Ton. The Rural Godown may accommodate 100 metric ton materials benefiting of 100 numbers of farmers. The Open Auction Yard is to avoid the farmers produce from the sun and rain. The work carried out by availing loan from NABARD (RIDF) Tranche XVII.

Opening of Arts & Craft Village

The Arts & Craft Village has been inaugurated by the Hon'ble Union Minister for Urban Development and Parliamentary Affairs M. Venkaiah Naidu at Murungapakkam, Pondicherry on 01.02.2016.



This project is modelled on the lines of the Dilli Haat, the Arts and Crafts village will provide an institutional platform for the traditional artisans of Puducherry and neighbouring States. Arts and crafts from the five south Indian states including Terracotta, Thanjavur paintings, antiques, studio pottery and hand made goods will be presented in this village.

The village located in an expanse of 4.1 acres was conceived to reinvigorate manufacture and sale of handicraft indigenous to various regions and is expected to benefit skilled artisans across the country. It has 24 permanent stalls for artisans, a demonstration and exhibition block to showcase the masterpieces of various artisans, an open-air theatre and a conference hall and a workshop and training centre.





Public Works Department

Construction of Road over Bridge over Upparnar drain connecting Kamaraj salai at Balaji Theatre Bridge and Maraimalai Adigal salai at Newtone theatre, Puducherry is taken up at a cost of ₹43.15 crore for a length of 730 metre and foundation stone was laid by the Hon'ble Chief Minister, Government of Puducherry on 22.02.2016



Improvements and relaying of urban roads in Puducherry (Phase-I) is taken up at a cost of ₹36.86 crore and Bhoomi Pooja was performed for commencement of 46 urban road works by the Hon'ble Chief Minister on 22.02.2016.

Bhoomi Pooja was performed by Hon'ble Chief Minister on 27.01.2016.

Construction of a circular Over Head Tank for a capacity of 5.00 lakhh litres and construction of circular under ground reservoir for a capacity of 2.50 lakh litre at Pandachozhanallur village in Nettapakkam Commune, Puducherry completed at a cost of ₹1,59,30,000/-. Construction of indoor stadium at Karaikal is completed at a cost of ₹14.07 crores with gallery capacity of 1500 persons and inaugurated by Hon'ble Chief Minister on 27.01.2016.

The 300 houses build nearly 6 hectors of land with the basic amenities. Each house has a built up area of 364 square feet provided proper sewage treatment plant and overhead tank, sodium vapor lamp on the streets and an Anganwadi.



Scheme for Socio Economic Development

- Free Distribution of House Sites / Construction Houses: Under this scheme of free distribution of House Sites/Houses, 1150 persons belonging to SC/OEBC were issued with free House sits/constructed Houses in Puducherry Union Territory during the year 2015-16 by the Adidravidar Welfare Department.
- House Construction / Damaged Houses Reconstruction Subsidy (Plan): This department is granting Housing subsidy under the scheme "Bharat Ratna Rajiv Gandhi Housing Construction Scheme" of Rs. 4.00 lakhs. There are 2400 beneficiaries were sanctioned with these Housing subsidies in the U.T. of Puducherry
- Construction of sanitary latrines (Plan): This Department is granting subsidy of Rs.20,000/- to BPL SC people for construction of sanitary latrines in their houses by themselves. Under the scheme the achievement of 52 against the physical target of 80 in 2015-16.
- Financial Assistance for taking medical treatment for prolonged Treatment: Under the Scheme, Rs.2,000/- per month, is being granted to poor SC patients who are unable to work to earn their livelihood due to prolonged diseases (Plan). Under this scheme achievement of 1489 against the physical target of 1000.
- Vocational Training (Non-Plan) on cutting and tailoring is imparted to poor SC dropout girls in School & Colleges. Each trainee is paid with a stipend Rs.750/- per

month each. After completion of one year training, all the successful candidates are provided with one sewing machine each to continue their carrier. Under the scheme achievement of 45 against physical target of 48.

Distribution of free pattas to beneficiaries

745 (Seven hundred and forty five) nos of pattas have been distributed to landless labourers by Survey and Land Records Department.

Agriculture Department

Relief measures were extended to the tune of Rs.22 crores for the farmers of Puducherry, Karaikal and Yanam regions for the crops damaged during heavy rains in North East monsoon 2015.

NABAED has sanctioned loan assistance to the tune of Rs.620.17 lakhs under rural infrastructure development fund for the Construction of Rural Godowns/Market auction Yards at various places in Puducherry, Karaikal and Yanam regions.

An innovative scheme for Pollination support trough Bee Keeping under National Horticulture Mission (NHM) is implemented through which farmers and urbanites were imparted two days training on Honey Bee keeping. Bee keeping equipments, Honey Bee colonies with Bee hives were distributed at subsidized cost to the beneficiaries.

The Agricultural Technology Management Agency (ATMA) has played a significant role in organizing the farmers into commodity interest groups (CIG) and to build their capacities on technological requirements. Two numbers of Farmers producers Organization such as Puducherry Agro Products Producers Ltd., and Hi-tech Horticulture Produces Company Ltd., have been registered and the first Puducherry Agro Products Producers Company was inaugurated on 6th March 2016 at Villianur, Puducherry.

Town and Country Planning

Hon'ble Chief Minister gave allotment orders of the tenement constructed at Lambart Saravanan Nagar, Puducherry on 26.02.2016. 189 Nos. of tenements benefitted.
