NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with the Notification No. F5/4/65-GP, dated 11th January 1965 of the Ministry of Home Affairs, Government of India, New Delhi and in supersession of the Government of Puducherry, Planning and Research Department, Planning Officer and Investigator Recruitment Rules, 1991 issued in the Planning and Research Department's G.O. Ms. No. 10/91/PRD, dated 1st July 1991 and published as Supplement to the Gazette No. 30 of the 23rd July 1991, save as respects things done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry, hereby makes the following rules regulating the method of recruitment to the Group 'C' post of Investigator in the Planning and Research Department, Puducherry, namely:-

1. *Short title and commencement.*— (i) These rules may be called the Government of Puducherry, Planning and Research Department Group 'C' post of Investigator Recruitment Rules, 2015.

(ii) They shall come into force on and from the date of their publication in the official gazette.

2. *Application.*— These rules shall apply for recruitment to the post specified in column (1) of the Schedule annexed hereto.

3. *Number of post, its classification and Pay Band and Grade Pay/Pay Scale.*— The number of the said post, its classification and the Pay Band and Grade Pay/Pay Scale attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed hereto.

4. *Method of recruitment, age-limit and other qualifications.*— The method of recruitment to the said post, age-limit, qualifications and other matters relating to the said post, shall be as specified in columns (5) to (13) of the said Schedule.

5. *Disqualifications.*— No person,—

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Lieutenant-Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

6. *Power to relax.*— Where the Lieutenant-Governor is of the opinion that it is necessary or expedient so to do, he may by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

7. *Saving.*— Nothing in these rules shall affect the reservations, relaxations of upper age-limit and other concessions required to be provided for the scheduled castes, ex-servicemen and other special category of persons in accordance with the orders issued by the Government from time to time in this regard.

Educational and other qualifications required for direct recruits. | Essential : A Degree of a recognized University in Economics/Statistics/Mathematics/Commerce/Computer Science/Social Sciences. Desirable : (i) A Master's Degree of a recognized University in any one of the above subjects or its equivalent. (ii) Experience in Computation work/Office procedure/Field surveys. (iii) A pass in Typewriting in English in Higher Grade. (iv) Working knowledge of Tamil. |
| 8. Whether age and educational qualifications prescribed for direct recruits will apply in the case of promotees. | : Not applicable |
| 9. Period of probation, if any | : Two years |

10. Method of recruitment, whether by direct : By direct recruitment
recruitment or by promotion or by deputation/
short-term contract and percentage of the
vacancies to be filled by various methods.
- Note* : Vacancies caused by the incumbents being away on deputation or long illness or study leave or under other circumstances for a duration of one year or more may be filled on deputation basis from officials of Puducherry Administration—
- (a) (i) holding analogous posts on regular basis in the parent cadre/department; or
(ii) with 8 years service in posts in Pay Band-1 ₹ 5,200-20,200 with Grade Pay ₹ 1,900 rendered after appointment thereto on a regular basis; and
(b) Possessing the educational qualifications prescribed for direct recruits under column (7).
- [Period of deputation (ISTC) including the period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central/State/Union Territory Government shall ordinarily not exceed 3 years. The maximum age-limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.]
