





Way forward for the year 2023-24

During the pre-budget meeting/discussions for RE 2022-23 & BE 2023-24 held during the month of October/November 2022, MHA/MoF, Government of India has stressed the necessity to enhance the UT's own receipts by following means:-

- ✓ Enhancement of Property Tax
- ✓ Enhancement of GLR Value
- ✓ Enhancement of User charges in various Departments
- ✓ Reduction of Grant in aid to Govt. Undertakings / Institutions / Societies

Way forward for the year 2023-24

Being a UT, Puducherry does not get financial devolution as part of the Finance Commission.

Puducherry however has to provide its share for CSS at par with other States. Funding pattern for CSS for Puducherry should be at par with that of other UTs (100% Central share)
