**MINUTES OF THE 4<sup>th</sup> MEETING OF STATE UID IMPLEMENTATION COMMITTEE**  
**HELD ON 18.04.2011**

The 4<sup>th</sup> meeting of State UID Implementation Committee to review the progress of Aadhaar enrolments in the UT of Puducherry was held on 18/04/2011 at 4.00 p.m. under the Chairmanship of Chief Secretary. The meeting was attended by the Members and Senior Officials.

2. Chief Secretary requested Registrar-cum-Director (CS & CA) to update the Committee about progress made so far. Accordingly, Registrar made a through Power-Point presentation to apprise the status. It is noted that

- As against the target of ₹. 1,33,626 for two months period (February & April 2011) proposed for Puducherry region, the enrolment of Aadhaar was ₹.37,397. Due to General Elections the targeted enrolment could not be achieved.
- 23 FPS shops were selected and the Enrolment Centres were set up one per each of the 23 Assembly Constituencies in Puducherry region.
- People without Ration Cards were also permitted to enroll their name at the above centres.
- The Centres were open for a period of 10 to 15 days at a stretch.
- Retired government servants selected through an open advertisement have been appointed as Verifiers. 2 or 3 Verifiers have been posted at each Enrolment Centre to verify the proof of address and proof of identity. These verifiers have all been provided necessary training before posting.
- Honorarium of ₹7000/- & ₹6000/- per month will be paid to Verifiers for rural and urban areas respectively.
- The mode of expenditure for the enrolment amount of ₹50/- per Aadhaar with break-up details was explained by the Registrar.

3. DDG (UIDAI) suggested that a coverage of 70-80% of the Ration Card Holders may be treated as a successful coverage in the first round. The second round later could cover the remaining people.

4. The following were the important operations/decisions taken in the meeting:-

- Set up Enrolment Centres on a permanent basis in school buildings as per public convenience. Directorate of Education will issue suitable instructions to all Heads of Schools to facilitate this as per Registrar's request.

- Arrange wider publicity through Local TV Channel, Dailies, Cinema Theatres and other available media, training of elected representatives etc. to popularize the Aadhaar Enrolment among the public and make them to enroll their name within the time limit prescribed for their respective area. The system Integrator will be asked to furnish a Media Campaign Plan as per contract to Registrar within a week's time.

[Action – Registrar]

- Registrar (UID) should immediately prepare an Overall time bound Plan of Action for the implementation of UID Programme in the UT of Puducherry on the lines of (Plan prepared) by the Election Department for the Assembly Elections 2011 in Puducherry.

[Action – Registrar]

- As against the fund of ₹ 6.00 Crores to be provided by UIDAI @ ₹ 50/- per enrolment, the estimated expenditure in this connection will be approximately ₹ 2.56 crores, leaving the balance amount of ₹ 3.44 Crores. The decision on the utilization of this amount will be taken later as per progress of implementation of the Project.

[Action – Registrar]

- The payment of ₹ 100/- to the members of BPL/BPL+ family, will be disbursed through the Officials of Revenue Department to the individual as and when the Aadhaar number was assigned by UIDAI, New Delhi after de-duplication process.

[Action – Registrar / Revenue Department]

- In order to finalise a comprehensive proposal for ICT Infrastructure for submission to UIDAI, Registrar will arrange a separate meeting at Chief Secretary's level of all concerned within a week.
