MINUTES OF THE MEETING "FOR UTILIZING AND LEVERAGING 'AADHAAR' AS A PLATFORM FOR SERVICE DELIVERY" HELD ON 28.06.2011 AT 5.00 PM

As advised by the Union Cabinet Secretary to draw up a time bound action plan for utilizing and leveraging Aadhaar as a platform for service delivery in Government Departments, a meeting under the Chairmanship of Chief Secretary-cum-Chairman (State UID Committee) was held on 28.06.2011 at 5.00 PM. The meeting was attended by 18 Head of Departments/Agencies/Corporation implementing the welfare schemes.

At the outset, Chief Secretary welcomed all and briefed about the importance of recognizing Aadhaar as a proof of identity and proof of address in the various resident centric welfare schemes offered by the State. The following points emerged in the meeting:

- > Aadhaar Number shall be one of the requirements in the Application forms issued to public for availing the benefits.
- At the first instance, the existing format of prescribed application forms along with the Rules thereof to avail the benefits available in Govt. departments which are implementing the welfare schemes have to be collected by Planning and Research Department. After scrutiny the new formats integrating Aadhaar Number may be devised for use.
- > After incorporating the Aadhaar Number as one of the requirements in the application form, as per the advise of the Committee, should be placed before the Cabinet for its approval.
- Subsequently all the Government Departments / Agencies / Corporations shall be informed to incorporate the requirement of Aadhaar Number in all its Application Forms.
- A Committee to draw-up a time bound action plan for utilizing and leveraging Aadhaar as a platform for service delivery in Govt. institutions may be formed.

With this, the meeting came to an end.
