

WEIGHTS AND MEASURES

Under weights and measures sector, the Government has enacted certain legislations in order to have legal control over industrial movements and human safety and to create effective enforcement machinery. The registration of users of weights and measures are subject to periodical verifications. In order to enforce the legislations, two four wheelers were purchased during the Ninth Plan. Periodical inspections of Fair Price Shops, business establishments, manufacturing industries and site stamping were undertaken. During the Tenth Plan, it is proposed to participate in seminars and exhibitions in order to create awareness, purchase / upgradation of computers and creation of certain posts.
