

## URBAN DEVELOPMENT

During the Ninth Plan, works namely widening of Vazhudavur road, barricading wall and pavement along Gingee Salai, construction of shopping complex at Jawahar Nagar, Construction of market at Lawspet , Aziz Nagar and Nellithoppe etc. were taken up. 29,564 nos. of slum dwellers have been benefitted. Reviewed Comprehensive Development Plan for Pondicherry and Comprehensive Development Plans for Karaikal and Yanam have been notified, Development Plan for Bahour and Villianur was completed, Seminars were conducted on Building Bye-laws and housing problems. Digitisation of Pondicherry regional map was completed, Aerial photographs for Pondicherry procured.

Acquisition of land and development of market at Karaikal; Improvement of important roads, development of parks and city greening in Pondicherry, construction of shopping complexes, development of urban forest and creating 'Heritage Fund' , construction of a Swimming Pool Complex etc. are the main proposals for the Tenth Plan. Improvements to the area around Nehru statue and Central park, beach and Goubert avenue, Grand canal and roads on either side and Grand bazaar are certain specific action areas. Importance will be given to preserve Cultural Heritage and architecture of Urban Settlements. Separate provision for the 'Heritage Fund' under Plan will be included for maintenance and improvement of Heritage buildings in the Boulevard town, Pondicherry. During the Tenth Plan, the Slum Improvement Board must extend 4 out of 7 basic amenities - proper streets, water supply, community latrines and community baths in all the slum areas in a phased programme.

Improvement of the road network, laying and construction of bye pass road, installation of traffic signals, conducting study on implementation of MRTS and subsequent execution of related works etc. form part of the traffic and transportation improvement. Further, improvements to the Boulevard roads and 4 main roads converging to the city and the bye- pass will be undertaken. The feasibility to develop 'Air Bus' routes to ease the congestion on city roads and pollution free electric mini buses will also be tried as town buses.

In order to cope with the fast trend of commercialization, Municipalities have to develop new shopping complexes apart from expanding the existing bazaars. Marketing complexes have to be developed in all the localities to ease out congestion in the town area. Sanitation is an important aspect of Municipal Administration. Dependence of human labourers has to be reduced and more mechanical instruments should be introduced in the field of sanitation. More centralised method of solid waste disposal point has to be identified. Fast industrialisation, shrinking of agricultural activities in the peripheral areas and proliferation of slum areas have added to the burdens of the Municipalities which are finding it difficult financially even to meet their statutory requirements/responsibilities. Urban poverty alleviation has also become one of the important tasks of the Municipality. Keeping in mind the financial status of these Municipalities it is required to assist them to take up developmental works including urban poverty alleviation programme during the Tenth Plan. It is proposed to assist the

Municipalities for the construction of Kalyanamandapams / Tourist motels / guest houses etc.

The urban area of Pondicherry Town is divided into six planning zones for the implementation of sewage collection / disposal covering a total area of 2294 Ha. Sewerage schemes have already been completed and commissioned in Eighth and Ninth Plan in two zones (Pondicherry and Muthialpet) covering a population of 1,25,000. In the Annual Plan 2000-01, a sewerage scheme covering Rainbow Nagar, Venkata Nagar, Kamaraj Nagar to an extent of 71 Ha to serve a population of 19200 persons is being implemented. Two more planning zones will be taken up for providing sewerage in Tenth Plan. One additional oxidation pond is being constructed at the Karuvadikuppam sewage treatment plant.

Presently, 16 MLD of sewage is being collected and treated in oxidation ponds and the effluent is used for raising fodder crops, bamboo trees etc. In order to improve the capacity of sewage treatment plant and also to diversify the use of treated sewage, the advanced treatment process called "DUCK WEED TREATMENT PLANT" is proposed to be implemented in Pondicherry during Tenth Plan similar to the system existing in Bangladesh. A project feasibility report on this has been obtained from AIC Watson Ltd., Bombay and technical approval for the scheme in principle has also been obtained from CPHEEO. The cost of the project will be around Rs.3.00 Crores.

a) Construction and improvement of buildings: This scheme envisages financial assistance to Municipalities towards construction/improvement of buildings/ Kalaiarangam/Night Shelters/Markets buildings/Auditorium/Slaughter houses, bus stand, Community halls and other buildings etc.

b) Road works and water supply works have been transferred to Roads and Bridges and Water Supply and Sanitation Sectors respectively from the Tenth Five Year Plan onwards.

c) Under the Local Area Development Programme, Members of Legislative Assembly may select area from the constituency from which he/she has been elected for exercising the choice of works for which local bodies will be assisted to implement the works selected by them. Under this programme, the financial assistance per MLA was given at the rate of Rs.25.00 lakhs per constituency. It is also proposed to construct staff quarters for the Municipal employees.

d) Assistance for computerisation: The Municipalities are performing various functions viz. provision of civic amenities to the public, collection of revenue by means of House Tax, License, etc. functioning as Birth & Death Registration units which involves clerical work and delay in disposal of public nature particularly the requirement of the public. Hence for the better efficiency and speedy disposal of the public nature, the Municipalities have to be computerised.

- 1. Name of the Scheme** : Financial Assistance to Municipalities for Sanitation, Solid and Liquid Waste Management
- 2. Objective of the Scheme** :

During 1999-2000 of the Ninth Plan period, this scheme was formulated with a view to assist the local bodies by the way of grant to take up project and work relating to sanitation and scientific disposal of solid and liquid waste including strengthening of sanitary wing of urban local bodies. For the past two years, funds to the tune of Rs.80.00 lakhs (Rs.40 lakhs per year) has been released to Pondicherry Municipality for purchase of Dumper placer containers (29 Nos.), BOBCAT, Hand drawn garbage carts, etc. and also for the execution of civil works connecting to the drainage cleaning. Similar grants has to be released to other Municipalities also if they require in future for this purpose.

Besides site to the extent of 15H-22A-00SC has to be acquired at the cost of Rs.1984 lakhs for the purpose of setting up of solid waste processing unit and truck terminal in Thattanchavady village for Oulgaret, Pondicherry Municipalities and Villianur, Ariankuppam Commune Panchayats in order to provide proper compost yard are to be set up in the outlying regions of Karaikal, Mahe and Yanam for which sufficient funds are to be provided in the Tenth Five Year Plan.

Frequently, Pondicherry, Oulgaret and Karaikal Municipalities are coming up with the proposal for conducting special cleaning programme to keep the city clean either at the instance of the Hon'ble Chief Minister or at the instance of the Public/ Government. For this purpose, they are requiring special grants. Instantly, the Pondicherry Municipality has sought for special grant to the tune of Rs.63.00 lacs for continuing special cleaning campaign. This could not be granted to the Municipality as funds are not

available. As such, to meet this type of eventualities, sufficient grants may be provided for conducting special cleaning campaign under this scheme.

- 1. Name of the Scheme** : Strengthening of Municipal Administration
- 2. Objective of the Scheme** :

Though the concept of Local Self Core Services Government existed in this part of the country right from Pallava days, a attempt at self governance distilled through the French Avratte of 1880. The post merger scenario witnessed the enunciation of Municipalities Act and Commune Panchayats Act, 1973 which gave further impetus to Local Self Governance. Subsequent 73<sup>rd</sup> and 74<sup>th</sup> Constitutional amendments gave birth to Nagar Palikas and Panchayat Raj Institutions which further widened the scope of local self governance to manifold extent. Therefore, it has become necessary to have a proper administrative structure for effective control and supervision of the functioning of local bodies. The plan schemes implemented by Local Administration Department have multiplied exponentially during the past plan periods. To cite a concrete example in terms of facts and figures, the total outlay of plan schemes executed during the year 1985-86 was Rs.101 lakhs, which has now touched Rs.2,566 lakhs during the year 2001-2002, signaling a quantum leap in the plan expenditure. Besides many centrally sponsored schemes such as IDSMT, SJSRY, Slum Improvement Scheme, etc., are now being implemented by the Department. More significantly the Nagar Palikas and Panchayat Raj systems have brought in the institutions of local self governments at the gross root level.

The Panchayat Raj Institutions at the lower tier would bring forth 98 Village Panchayats and 98 Grama Sabhas spread out in 815 Village Panchayat Wards. At the higher tier, there will be 98 Commune Panchayat wards in 10 Commune Panchayats. Parallely in the urban scenario, there will be 122 Municipal wards in 5 Municipalities. These self governing units will exercise various functions ranging from street lighting to garbage removal, from Agriculture to Town Planning and Industrial licensing as envisaged in the Constitution of India. Such devolution of functions involve transfer of funds, functionaires and financial autonomy which calls for control and supervision at the Directorate level. The Directorate has to be strengthened and the new post for the Municipal Administration are suggested in the Tenth Plan. Proposals.
