HOUSING

Under the Public Works Housing, it is proposed to construct Chief Minister's Bungalow and Ministers' Quarters, Quarters for Secretaries (2 Nos.), Type-I Quarters (11 blocks – 66 tenements), (10 blocks – 60 tenements) for Government Servants at Olandai. Quarters at Lawspet, Govt. Servants quarters Type-I (8 Blocks 48 units), Type-II (6 Blocks 36 units), Type-III (2 blocks 12 units) at Kottucherry, Karaikal, Land acquisition for Govt. Servants Quarters and construction Of Govt. Servants Quarters (6 units) at Yanam and construction of quarters and acquisition of land for construction of quarters at Mahe and construction of quarters for health personnel and staff of government press.

Under Fire Service housing, acquisition of land, construction of fire station building with quarters will be taken up. Acquisition of land for the construction of Directorate is also contemplated.

Under Police housing scheme, it is proposed to acquire of land for Lawspet, Mettupalayam, Odiansalai police stations and for Korkadu out post. Approach roads to Sedarapet and Maducarai outposts, reconstruction/restoration of IGP Complex, Phase I. II. & III. construction of Police Stations with staff quarters at Orleanpet, Odiansalai, Lawspet, and Mettupalayam and Out-Posts with staff quarters at Korkadu and Sedarapet, construction of 3 IPS quarters for IGP and 2 SSPs at Gorimedu/Shanmugapuram, construction of Swimming Pool at Police Complex, Gorimedu, conversion of Mini Firing Range into Indoor Firing Range at Shanmugapuram Police Complex, acquisition of lands and construction of All Women PS and Traffic PS at Villianur, acquisition of land and construction of OP at Keezhore, construction of Compound Wall (Phase-III) at Police Complex, Gorimedu, Acquisition of lands and construction of Border Check Posts at Gorimedu border, Kanagachettikulam, Muthialpet/Kottakuppam border, Kanniakoil/Mullodai border, Pathukannu junction, Thirukkanur and Construction of separate building for Armory Unit near Mini Firing Range in the PAP Complex. Gorimedu, construction of safety compound wall around the Mini Firing Range in PAP Complex to contain public trespass in the prohibited area around range and improvement to the Firing Range bund work, conversion of existing open ground on the eastern side of Mini Firing Range as Parade/Play ground, construction of additional 2 barracks, store rooms and toilet block for the Band Unit near existing Band Unit building in PAP Complex, improvement works in the Police Quarters at D' Nagar, improvement works in the Police Quarters at Shanmugapuram, cleaning and improvement of bund work of the existing canal near Police Community Hall in the PAP Complex, providing internal gates arrangement in the PAP Complex, construction of compound wall on the western border of the PAP Campus, construction of additional four barracks with dining room and toilet block for the accommodation of PAP'A' 'B' 'D' & 'E' Companies in PAP Campus, construction of sump and motor for each residential block at PAP Complex - 40 Nos, acquisition of lands and construction of one Marine, Police Station, one Marine Police Out-Post at Pondicherry and Marine Police Observation Posts/Points along coastal land in Pondicherry region.

In the Karaikal region, construction of Police Complex comprising of Police barracks, play/parade ground, quarters for SP/CI, play court, Dog Kennel, vehicle garage, etc., at Oduthurai, Karaikal, acquisition of land and construction of All Women PS at Karaikal, construction of VIP suite at Lemaire Street, Karaikal, acquisition of land and construction of OP in Thirunallar temple, construction of 12 Nos. of quarters for Police Constables at T.R. Pattinam PS, construction of Firing Range at Karaikal, acquisition of lands and construction of Border Check Posts at Ambagarathur, Annavasal, Nallathur, Nandalar bridge and Mela Vanjore, acquisition of lands and construction of one Marine Police, Out-Post at Karaikal and Marine Police Observation and Posts / Points along coastal land are contemplated.

In Mahe region, it is proposed to acquire land and construction of OP at Chalakkara and East Palloor, acquisition of land and construction of Police Control Room at Mahe, construction of I floor to Paloor PS building, construction of SP office —cum — residence and VIP suite at Mahe, acquisition of lands and construction of Border Check Posts at Poozhithala, Makuny and Chokli.

In Yanam region, acquisition of land and construction of Traffic PS at Yanam, dismantling the existing dilapidated Police Quarters and construction of new quarters at Yanam, acquisition of land and construction of PS at Darialatippa, Yanam, acquisition of land and construction of Police Guest House(2 suites), Yanam, acquisition of lands and construction of Border Check Posts at Neela Palli and By pass road(new bridge to Yedurlanka), construction of Police vehicle shed at Yanam are contemplated.

Under Co-operative housing, it is proposed to provide financial assistance to the Housing Federation, Building Centre and Primary Co-operative Housing Societies. It is also proposed to give interest subsidy to the members of the Primary societies.

Under Town and Country Planning housing scheme, a new housing scheme in the Annual Plan 2003-04 under the Housing Sector namely 'Shelter for Houseless Poor (Perunthalaivar Kamaraj Centenary Housing Scheme for Houseless Poor-2003) was introduced. Under this scheme, it is proposed to give financial assistance to 7500 houseless poor families every year for the construction of houses at the rate of Rs.40, 000/- per house. The Department also implements some more schemes. A new scheme namely "State's share to Vambay" is proposed in the financial year 2004-05. Under this scheme, it is proposed to release State Government's matching share against the Central Government Share for the Centrally Sponsored Scheme, 'Vambay' for the construction of 800 houses and toilet blocks in urban slum areas.

Under survey housing 1200 beneficiaries will be covered under distribution of free house sites to landless labourers and 1000 beneficiaries will be given construction assistance at the rate of Rs.40,000/- per beneficiary. It is also proposed to enhance financial assistance to 1500 beneficiaries for conversion of thatched house into semi/pucca house. Under the AD Welfare housing programme construction subsidy at the rate of Rs.40,000/- will be given to 550 homeless SC people. Under DRDA housing a subsidy of Rs.40,000/- is given to eligible BPL families to construct their own houses. 100 beneficiaries is proposed to be covered under this programme Annual Plan 2004-05. Under the proposed new scheme 'State share of IAY' an amount of Rs.40,000/- will be given to 550 beneficiaries(Rs.20,000/- by Government of India + Rs.20,000/- from the UT administration)
