

## URBAN DEVELOPMENT

As elsewhere in the developing world, urbanization in India is accompanied by a number of problems arising from population concentration; high density, shortages of housing and civic amenities, traffic congestion; poverty, slums, environmental degradation etc. The Union Territory of Pondicherry is one of a highly urbanised entities with 66% of the population living in urban areas as per 2001 census. Such concentration has no doubt led to severe stress on the infrastructure facilities and urban amenities; traffic problems etc. despite concerted efforts. Unprecedented population growth added with the migration from the neighbouring states, rapid industrialisation, and fast pace of developments, have accelerated the urbanisation process in the Union Territory. The demand for urban space is therefore increasing constantly and the availability of adequate living space is under threat from other competing demands. Speculative land prices have also ensured that the urban poor are increasingly either crowded in the inner city areas or progressively marginalised to squatter settlements at the city periphery, the offshoots of which is the growing number of slums.

During 2004-05 Town and Country Planning department proposes to take up improvements to important roads, construction of swimming pool, extension of urban amenities to the town and sub-urban areas and release of state share for Asia urbs programme. Through the programme, environmental improvement in urban slums, 9,000 slum dwellers are proposed to be covered. Further, review of development plans for Pondicherry and regional plans for Pondicherry and Karaikal, heritage development plans and detailed development for Thirunallar temple town are proposed to be taken up.

It is proposed to assist the Municipalities for the construction of Kalyanamandapams Tourist Motel/Guest House etc. It is also proposed to give training to the elected members of the Municipal/Panchayat council as also staff of local bodies and Local Administration Department to improve their knowledge to work with upto date information/procedures. In addition to that water and sanitation committees, grass root level Voluntary beneficiaries, local technicians, local artisan and field level departmental functionaries, local panchayat functionaries will be trained suitably to tackle water supply problem.

In pursuance of the National Committee appointed by the Supreme Court to study the solid and liquid waste management and the Committee's interim report circulated to all states and in pursuance of the Home Ministry's directions to U.T. Government to take action, and in pursuance of the show cause notice issued by Pondicherry Pollution Control Committee to the Local Bodies in Pondicherry and so as to make the city more clean, revamped system of removal of garbage by privatization is necessary for which plenty of financial assistance needs to be given to the Local Bodies for Sanitation, Solid and Liquid Waste Management since they are financially very weak.

In view of ensuing civic elections, to accommodate the elected members, buildings are felt necessary to transact their business. Hence a scheme "Construction of Municipal Office Buildings" has been taken up. A new scheme viz., Grants to Municipalities for development of Villages under Perunthalaivar Kamarajar Village Renaissance scheme has been proposed.

A quantity of 16 MLD of sewage is being collected and treated in oxidation ponds at present. The effluent is used for raising fodder crops, bamboo trees etc. In order to improve the capacity of sewage treatment plant and also to diversify the use of treated sewage the advanced treatment process duck weed treatment plant is proposed to be constructed in Pondicherry during the year 2004-05 similar to the system existing in Bangladesh. Out of the total quantity of town sewer 2.50 MLD, sewage will be treated through the above plant.

As such, it is imperative on the part of the Municipality to construct new municipal offices. Accordingly, funds have been provided.
