## **CO-OPERATIVE**

The Pondicherry State Cooperative Housing Federation Ltd. is the apex institution for the primary Cooperative Housing Societies. Pondicherry State Cooperative Housing Federation Ltd. is issuing loans to the Primary Cooperative Housing Societies to facilitate issue of loans to their members. In order to raise the borrowing capacity and strengthen the activities of the Housefed, it is proposed to provide Government financial assistance of Rs.260.00 lakhs as share capital for the year 2005-06. The Pondicherry Cooperative Building Centre sells all kinds of the quality building materials at reasonable rates to the individuals. In order to meet working capital requirements, share capital assistance will be provided to the Pondicherry Cooperative Building Centre.

In order to raise the borrowing capacity and to strengthen the activities of the Mahe Cooperative Housing Society, Mahe and Yanam Cooperative Housing Society, Yanam it is proposed to provide share capital assistance of Rs.5.00 lakhs, each society respectively. During the year 2005-06, considerable no. of members around will be benefited under the scheme by providing finance to the tune of Rs.403.60 lakhs.

## TOWN AND COUNTRY PLANNING

It is proposed to develop 200 EWS plots with basic infrastructural facilities, construction of 200 tenements and 120 LIG houses are proposed. Training will be imparted to 150 skilled and unskilled labourers through building centres in cost effective building techniques under the Perunthalaivar Kamarajar Housing Scheme for Houseless poor families homeless at the rate of Rs.40,000/- will be given to 7500 BPL families. Matching grant for VAMBAY scheme will be provided for taking up of construction of 800 houses and toilet blocks in urban slums. A subsidy out of Rs.10,000/- will be provided to the beneficiaries of Perunthalaivar Kamarajar Housing Scheme towards construction of 3000 toilets.

# AD-WELFARE

House construction subsidy is given to 866 SC people to construct the houses in their own plot. The financial assistance in the form of subsidy to the tune of Rs.40,000/- is extended to them with a view to enable them to construct a house of their own. The subsidy is being given in three instalments based on the stages of construction and also it is proposed to cover 800 SC homeless people.

## D.R.D.A.

Under DRDA housing a subsidy of Rs.40,000/- is given to eligible BPL families to construct their own houses. 350 beneficiaries is proposed to be covered under this programme in the Annual Plan 2005-06.
