

URBAN DEVELOPMENT

Any policy initiatives under Urban Development sector have to be seen and solutions chalked out. The solution lies in promoting sustainable cities / human settlements. In effect it should aim for a "Clean City", a city with proper solid waste, effluent and air pollution management; a "Green City" with a good green cover and landscaped open spaces; a "Prosperous City" which is economically efficient; and socially equitable; and a "Sustainable City"; which is environmentally sustainable, so that it can meet today's needs without jeopardising the chances of the future generation to love and sustain themselves.

Development of land at saram revenue village, improvement of roads and construction of market, Environmental Improvements to 12500 urban slum population, review of Development plan and heritage development plans for boulevard town, and development plan for temple towns. In order to cope with the fast trend of commercialisation these Municipalities have to develop new shopping complexes apart from expanding the existing bazaars. Marketing complexes have to be developed in all the localities so as to discourage the people of that localities from going to town for the purpose of shopping. Further, it is proposed to establish an Inter-State Bus Terminal at Oladai Keerapalayam so as to avoid heavy traffic within city limit. Sanitation is an important aspect of Municipal Administration. Dependence of human labourers has to be reduced and more mechanical instruments should be introduced in the field of sanitation. Hence, it is proposed to introduce revamped system of garbage collection (Hyderabad pattern) within the Boulevard Area for which considerable quantum of grant-in-aid need to be released in view of limited financial resources of the Municipalities.

Fast industrialisation, shrinking of agricultural activities in the peripheral areas, proliferation of slum areas have added to the burdens of the Municipalities who are finding it difficult financially even to meet their statutory requirements/responsibilities. Urban poverty alleviation has also become one of the important tasks of the Municipality. Keeping in mind the financial status of these Municipalities it is required to assist them to take up developmental works including urban poverty alleviation programme.

It is proposed to assist the Municipalities for the construction of Kalyanamandapams / Tourist Motel / Guest House etc. It is also proposed to give training to the elected members of the Municipal / Panchayat council as also staff of local bodies to improve their knowledge to work with upto date information/procedures. In addition to that water and sanitation committees, grass root level Voluntary beneficiaries, local technicians, local artisan and field level departmental functionaries, local panchayat functionaries will be trained suitably to tackle water supply problem.

During 2005-2006, it is proposed to take up various developmental works atleast to a desirable extent. Provision has also been made for conduct of training course for the local body staff and LAD staff members, water and sanitation committee (local beneficiaries), local technicians, local artisans. The programme envisaged by Public Works Department under this sector relates to extension of sewerage facilities to urbanisable areas of Pondicherry. During 2005-06, Construction of 2.5 MLD Duck weed based water water treatment plant at Lawspet (Primary treatment plant with UASB and allied works). (Secondary treatment with duckweed pond, fish pond and allied units), Sewerage scheme for the areas covered by Cuddalore Road (Zone III Phase I, II and III) , Sewerage scheme for the areas covered by Kamaraj Salai, ECR, Karuvadikuppam main road, Karuvadikuppam drain, Krishna Nagar Main Road, Annai Nagar (Zone-IV, sector-III, Phase III) ,Sewerage scheme for the areas covered by Airport Road, ECR, and College Road at Lawspet (ZoneV, Sector I, Phase-I, Stage-I) and other sewerage schemes viz., for Zone-III Mudhaliarpet Phase-I/II/III , Lawspet (Phase I to IV) Brindavan Phase-I/II , Nellithope have been proposed. It is proposed to undertake ground sewerage system in Karaikal region.

including strengthening of sanitary wing of urban local bodies. Funds will be released to local bodies for purchase of Dumper placed containers, BOBCATS, Hand drawn garbage carts, etc. and also for the execution of civil works connecting to the drainage cleaning. Frequently, Pondicherry, Oulgaret and Karaikal Municipalities are coming up with the proposal for conducting special cleaning programmes to keep the city clean either at the instance of the Hon'ble Chief Minister or at the instance of the Public/ Government. For this purpose, they are requiring special grants. As such, to meet this type of eventualities, sufficient grants may be provided for conducting special cleaning campaign under this scheme.

So as to make the city more clean, revamped system of removal of garbages by privatization is necessary for which considerable quantum of assistance is required to be released to the Municipalities in view of their weaker financial position. It is also proposed to acquire land of an extent of 9H-66A-65ca at Kurumbapet Revenue village for dumping garbages and setting up of Solid Waste Processing Unit.

1. Name of the Scheme : Financial Assistance to Municipalities for the Construction of Municipal Office Buildings

2. Objective of the Scheme :

The civic elections are to be held shortly. There is no municipal office building in existence. After election, the councilors need office buildings to sit and transact their day to day business. Hence a new scheme has been proposed with the following objectives.

Consequent to the 73rd and 74th amendment of the Constitution, the Municipal election will have to be conducted in the respective municipal jurisdiction. At present, there is no Municipal office building to enable the Municipalities to transact their day to day official business.

Most of the few buildings owned by the Municipalities like Community Halls, etc. could not be accommodated from the municipal councils since they are all damaged and also required for public utility. As such, it is imperative on the part of the Municipality to construct new municipal offices. Accordingly, funds have been provided.
