## DAIRY DEVELOPMENT

The main objective are:-

- i) In order to uplift the socio-economic conditions of the milk producers, milch cattle are developed by increase in milk yields, milk producers are benefited. Remunerative price for milk is ensured.
- ii) To maintain an effective system of the milk and milk products at reasonable price to the consumers.
- iii) To provide subsidiary occupation to farmers to supplement their income so as to improve their standard of living.

Under Operation Flood III the Pondicherry Dairy was expanded to handle 50000 litres every day. All the primary Co-operative milk producers societies were converted into Anand Pattern societies with veterinary coverage at the door steps of milk producers. Pondicherry Co-operative Milk Producers' Union is funded by the National Dairy Development Board. Necessary steps are being taken to convert the primaries in Karaikal on Anand Pattern.

During 2005 - 06 it is proposed to assist Pondicherry Co-operative Milk Producers' Union for setting up of 2 chilling centre at a cost of Rs.36.00 lakhs. It is also proposed to grant share capital assistance to the tune of Rs.50.00 lakhs to strengthen its working capital base.

It is proposed to establish two mini dairy chilling plant in rural areas of Pondicherry region. An amount of Rs.118 lakhs is proposed for the establishment of Mini Dairy Plant.
