

URBAN DEVELOPMENT

The Union Territory of Pondicherry is one of a highly urbanised entities with 66% of the population living in urban areas as per 2001 census. Such concentration has no doubt led to severe stress on the infrastructure facilities and urban amenities; traffic problems etc. despite concerted efforts. Unprecedented population growth added with the migration from the neighbouring states, rapid industrialisation, and fast pace of developments, have accelerated the urbanisation process in the Union Territory. The demand for urban space is therefore increasing constantly and the availability of adequate living space is under threat from other competing demands. Speculative land prices have also ensured that the urban poor are increasingly either crowded in the inner city areas or progressively marginalised to squatter settlements at the city periphery. The offshoots of which is the growing number of slums. It is in this background, any policy initiatives under 'Urban Development' Sector have to be seen and solutions chalked out. The solution lies in promoting sustainable cities / human settlements. In effect it should aim for a "Clean City", a city with proper solid waste, effluent and air pollution management; a "Green City" with a good green cover and landscaped open spaces; a "Prosperous City" which is economically efficient; and socially equitable; and a "Sustainable City"; which is environmentally sustainable, so that it can meet today's needs without jeopardising the chances of the future generation to love and sustain themselves.

During 2006-07, the following programmes are envisaged: (1) Development of parks, construction of shopping complex and improvement of roads, (2) Environmental Improvements to 8000 Urban Slum populations, (3) Review of Development plan and Regional Plans for Pondicherry and Karaikal, Digitisation of Development Plan for Karaikal and Yanam, and (4) Improvements to important roads, road infrastructure and junctions.

Pondicherry, the capital of the Union Territory is developing very fast in all fields viz. Industrialisation, commercial and Tourism. Oulgaret and Karaikal which are next to Pondicherry urban area, are also equally developing in all fields and demand more care and improvement. Moreover, these 3 towns are expanding year after year due to conversion of vacant land into housing colonies and hence lack of basic civic amenities and other infrastructural facilities. In order to cope with the fast trend of commercialisation these Municipalities have to develop new shopping complexes apart from expanding the existing bazaars. Marketing complexes have to be developed in all the localities so as to discourage the people of that localities from going to Town for the purpose of shopping and to avoid overcrowding. Hence, a Satellite market is going to be established at Pakkamudayanpet near ECR.

During the year 2006-2007, an amount of Rs.4000.00 lakhs has been proposed, so as to enable the Municipalities to take up various developmental works. Provision has also been made for conduct of training course for the local body staff and Local Administration staff members, water and sanitation committee (local beneficiaries), local technicians, local artisans. The constituency-wise allocation of Rs.7.00 lakhs under "Perunthalaivar Kamarajar Village Renaissance Scheme" will be enhanced as Rs.15.00 lakhs during the Annual Plan 2006-07. A provision of Rs.200.00 lakhs has been proposed for the year 2006-07 to take up Tsunami reconstruction works. The important major works under public sector during the Annual Plan 2006-07 are Road work at Lawspet main road to sewage farm, Laying of DI pipe wastewater p.m. from MPS to IPS Rs.300.00 lakh. Secondary treatment plant at Dubrayapet 2.50 MLD. Secondary treatment plant at Lawspet 5.00 MLD. Tack sewer at Lawspet, Purchase and Commissioning of AAS for Bio-chemistry, Sewerage scheme for the area covered by Sudhana nagar and adjoining areas (Zone-III, Sector-III), Sewerage Scheme for the area covered by Murungapakkam and adjoining areas (Zone-III, Sector IV), Construction of 5.0 MLD treatment plant near Sudhana nagar (Zone-III, Sector-III (and IV) and Sakthinagar & Velmurugan Nagar.

This scheme is formulated with a view to assist the local bodies by the way of grant to take up project and work relating to sanitation and scientific disposal of solid and liquid waste including strengthening of sanitary wing of urban local bodies. Funds will be released to local bodies for purchase of Dumper placed containers, BOBCATS, Hand drawn garbage carts, etc. and also for the execution of civil works connecting to the drainage cleaning. Frequently, Pondicherry, Oulgaret and Karaikal Municipalities are coming up with the proposal for conducting special cleaning programmes to keep the city clean either at the instance of the Hon'ble Chief Minister or at the instance of the Public/ Government. For this purpose, they are requiring special grants. As such, to meet this type of eventualities, sufficient grants may be provided for conducting special cleaning campaign under this scheme. So as to make the city more clean, revamped system of removal of garbages by privatization is necessary for which considerable quantum of assistance is required to be released to the Municipalities in view of their weaker financial position. This also proposed to set up a Solid Waste Processing Unit in the land acquired at Kurumbapet Revenue village during 2006-07.
