CIVIL SUPPLIES

Under Public Distribution System, Rice, Wheat, Sugar, Kerosene are regularly distributed through 413 Fair Price Shops to the 3.05 lakhs Ration Card Holders (APL 1.87 lakh card holders and 1.18 lakh BPL card holders) every month in the Union Territory of Puducherry. Out of these, 332 Fair Price Shops are run by the Co-operative Societies, 41 Fair Price Shops are run by Puducherry Agro Product Civil Supplies Corporation and 40 Fair Price Shops are run by Private and Women individuals. During the festival seasons additional quantity of commodities are distributed to the cardholders.

Under Targeted Public Distribution System, this administration is supplying 35 Kgs. of rice, i.e., 20 Kgs. at Rs.4.00 per Kg. and balance 15 Kg. at Rs.6.00 per Kg. which are to be sold @ Rs.6.35 per Kg. As per Government of India estimates, the number of BPL families in this Union Territory is 83,600. This figure comprises 32,200 beneficiaries under Anthyodaya Anna Yojana (AAY), for which a separate allocation of 1129 MTs of rice is made available by Government of India, for supplying 35 Kgs. per family per month at Rs.3.00 per Kg. For supplying 35 Kgs. of rice to the remaining 51,400, the Government of India is allocating 1797 MTs of rice every month at the BPL rate of Rs.5650/MT.

Though the Government of India estimate of BPL families in this UT is only 83,600 including 32,200 AAY beneficiaries, the number of BPL & AAY families identified in this UT are as detailed below, as per enumeration.

For supplying to the additionally identified BPL families of 34,455, APL rice allocated by Government of India at Rs.8,300/MT is to be utilized according to the actual requirement. In order to ensure that there is 100% of coverage of BPL families in this UT, this administration will require to pay a subsidy of nearly Rs.100 lakhs per month by supplying 20 Kgs. of rice at the heavily subsidized rate of Rs.4.00 per Kg. and the balance 15 Kgs. @ Rs.6.00 per Kg. The decision to supply rice at these rates has been taken by the local government and implemented from August 2005, considering the poor purchasing power of the BPL families and the amount to be borne each month by the Government.

As far as Anthyodaya Anna Yojana beneficiaries are concerned, the rice allocated by Government of India at Rs.3.00 per Kg. is supplied to the consumers at the same rate of Rs.3.00 per Kg. and the transportation and handling charges amounting to Rs.7.9 lakhs per month, is borne by the local government as subsidy. The Government of Puducherry is not implementing the Annapurna Scheme.
