

LAND REFORMS

Local Area Network (LAN) work has been provided in revenue complex and in all Taluks. Information kiosk has been procured and installed at Puducherry revenue complex, Oulgaret, Villianur and Bahour Taluks and in Registrar and Sub-Registrar offices of Pondicherry region, Karaikal and Yanam Sub-Taluk. Computer in Biometric fingerprints system have been purchased. Digitalization of FMB work has been taken. Action has been taken to replace the existing A0 size scanning with printer and a line of issue of patta copies in Puducherry and Oulgaret Taluks, Yanam Sub-Taluk and Karaikal district. During the 11th Plan period action will be taken to replace the computer systems and purchase of new systems wherever necessary.

In view of rapid increase in population, increase in number of land holdings resulting in a considerable increase of work-load for the functionaries, the Puducherry and Karaikal Taluks had been bifurcated into Pondicherry Taluk and Oulgaret Taluk in Puducherry region and Karaikal and Thirunallar Taluk in Karaikal region. Besides, Villianur Sub-Taluk and Bahour Sub-Taluks have been upgraded into Villianur Taluk and Bahour Taluk and Mahe and Yanam stands as Mahe Sub-Taluk and Yanam Sub-Taluk. It is proposed to implement a new scheme viz. “Strengthening of Survey Wing in Taluks and Sub-Taluks” to speed up the process of patta transfer, demarcation of land, etc.

1. **Name of the Scheme** : Updating of Land Registry and Issue of Patta Pass Book and Survey Training Programme.
2. **Objective of the Scheme** :

The scheme envisages mainly Computerisation of re-survey operations and updating of Land Registry in all the four regions of U.T of Puducherry. Work flow automation will be implemented in the taluks, in a phased manner.

3. (a) Actual Physical Achievement 2006-07 :

Updating land records has been started. The Town Survey scheme has been started in Oulgaret Taluk. Work flow automation for villianur has been implemented. Issue of Patta copy (RoR) across the counter was implemented in all Taluks.

(b) Anticipated Physical Achievement 2007-08 :

Updating land records has been continued during the year. The Town Survey scheme has been continued in Oulgaret Taluk. Proposed to impart training to 25 Revenue Officials. The preliminary Work of the following taks viz., integration of the Revenue and Registration, automatic initiation of mutation of registration, integration of textual and spatial RoR data and comprehensive integration of land details such as ownership, map, land value, encumbrance and crop details would be taken up during 2007-08. Purchase of furniture to the staff recruited in the vacancy places and for the existing condemned furniture.

(c) Programme envisaged for the Annual Plan 2008-09 :

Implementation of work flow automation in Patta transfer proposals, establishment of common service centre for providing revenue service to the public, the remaining works following in the 2007-08 will be completed by March 2009. Purchase of furniture to the staff recruited in the vacancy places and for the existing condemned furniture. Creation of necessary functional posts.

1. **Name of the Scheme** : Introduction of e-Governance

2. Objective of the Scheme :

The scheme envisages introduction of e-governance activities such as Local area network, lease line and installation of computer systems and purchase of computer hardware. Issue of patta copies across the counter to the public. To digitalise Cadastral maps by using Collabland software of NIC

3. (a) Actual Physical Achievement 2006-07 :

Settlement details of all the 129 revenue villages in the U.T. of Puducherry has been digitalised and validated.

(b) Anticipated Physical Achievement 2007-08 :

The cadastral maps of 61 revenue villages comprised in Villianur and Bahour taluks have to be digitized. The certified copies of FMB are being issued to the public on demand.

(c) Programme envisaged for the Annual Plan 2008-09 :

For digitization of FMB of remaining 68 villages, the salient features of the "Collabland" an identical software developed by NIC for dititizing the cadastral maps are being studied. The decision on finalization of vendor will be on merits. AMC will be taken to all computer hardware. Replacement of Plan Printer with scanner A0 size. Purchase of computer stationeries and hardware, etc.

1. Name of the Scheme : Panchayat window

2. Objective of the Scheme :

Based on the statement of conclusions signed between Union Minister for Panchayati Raj and Chief Minister of Puducherry, it has been committed to devolve the functions to PRIs through activity mapping, followed by matching transfer of funds in respect of devolved functions, which will require creation of Panchayat sector window in each department. Panchayat window will be entrusted with all relevant schemes pertaining to the activities devolved to village and commune panchayats including activity mapping. Since the process of activity mapping has not been completed, a token provision is provided in the Annual Plan 2008-09.
