#### **WEIGHTS & MEASURES**

In accordance with the current international practices, Legal Metrology has applications in the fields of commercial transactions, industrial equipments and instruments needed for ensuring public health and human safety. The law relating to weights and measures ensures that any article or goods which are to be sold by weight, measure or number should either be weighed, measured or counted accurately in the presence of the purchaser. In the field of industrial measurements then law envisages proper control on the accuracy of measurement carried out in industrial fields. As regards public health and human safety, the law ensures that the instruments such as clinical thermometers, blood pressure gauges, etc. used by the Medical Practitioners are accurate so as to avoid wrong diagnosis and incorrect medication.

# Stamping of Weights and Measures

According to Sec.22 of the Standards of Weights and Measures (Enforcement) Act 1985, "No Weight or Measure shall be sold, or offered, exposed or possessed for sale, or used or kept for use in any transaction or for industrial production or for protection unless it has been verified and stamped". Further according to the provisions of Sec .24 of the Act, every weight or measure so verified shall be periodically re-verified.
