PORT

As a part of its ongoing economic development plans, the Port department had awarded the work of Development of Puducherry and Karaikal Ports into deep-water ports with direct berthing facilities through private investment on BOT (Build, Operate & Transfer) basis, to two different private developers.

Government of Puducherry has entered into a Concession Agreement with a private developer namely, M/s Marg Constructions Limited, Chennai during January 2006 for the development of a deep water port at Karaikal through private investment on BOT basis for a period of 30 years. Phase I of the project was completed at an estimated cost of ₹ 417 crores. The port is in operation since June 2009 and has been handling various cargoes like coal, cement, sugar, fertilizers, urea, etc. The Cargo handled during 2009-10 is 1.1 Million Tonnes and Government of Puducherry has received an income of ₹ 1.26 crores as Concession fee during 2009-10. So far the Government of Puducherry has received an income of ₹ 1.27 crores as Concession fee for the current financial year (2010-11) against the estimated target of ₹.2.53 crores.

A Captive Marine Terminal Facility promoted by M/s Chemplast Sanmar, Chennai is also functioning at Karaikal since September 2007. This facility handles liquid chemicals viz ethylene and caustic soda exclusively for their use. During the year 2009-10, this facility had handled a total of 37,933 tons of cargo. The revenue earned by way of Port dues and landing dues is ₹ 7.21 lakhs. For the current financial year (upto Oct'10), the cargo handled is 31,963 tons and the revenue earned is ₹ 6.66 lakh.

Regarding the Pondicherry port project, the case filed by the Ministry of Home Affairs against the Pondicherry port project in the Supreme Court has been dismissed on 12.11.2010. The Pondicherry port project would be taken up soon after the private developer obtains the Environmental Clearance from the MoEF, Government of India, New Delhi.
