### **STATISTICS**

During the Twelfth Five Year Plan, it is proposed to revamp the statistical system on the lines of the recommendations of the National Statistical Commission and also on the pattern of Central Statistical Organization, Ministry of Statistics and Programme Implementation, Government of India with the following four components:

- > Strengthening of State Income unit.
- > Strengthening of Industrial Statistics unit.
- > Strengthening of Evaluation and Economic Survey unit.
- > Creation of Research and Analysis Wing.

It has been envisaged in the guidelines issued by the Planning Commission that a vision document in each district has to be prepared. It is proposed to modernize the department with latest IT tools for maintenance of data base and for achieving good governance through World Bank Assistance under ISSP scheme.
