1. Name of the Scheme : Welfare programme for Backward Class People

2. Objective of the Scheme :

The main objective of the scheme is to provide hostel facilities to the backward class boys and girls students and proposed to open ten hostels in all the four regions, to provide a bicycle free of cost to the students studying 9th Standard in the Govt./Govt. aided schools, to give Special awards to meritorious backward class students, to start coaching centre exclusively for backward class people for professional courses and free supply of tools and implements to OBC people.

3. Actual Physical Achievements during Eleventh Five Year Plan (2007-12) :

- i) Maintenance of 6 hostels with 875 inmates.
- ii) Admission of 125 new inmates.
- iii) Maintenance of posts.
- iv) 48,000 Nos. of bicycle and raincoats distributed.

1. Name of the Scheme : Welfare Programme for Disabled persons

2. Objective of the Scheme :

The main aim of the scheme is to provide scholarship to disabled students, to extend various welfare measures to disabled persons, to supply prosthetic appliances like motorized four wheeler (in valid carriage), tricycles, calipers, crutches, hearing aids, spectacle etc. to the needy disabled persons free of cost, to provide financial assistance to the totally disabled persons towards their maintenance, to create awareness on the early detection of handicapped. A social awareness for prevention of disabilities has to be generated and referring the detected cases to appropriate agencies for provisions of prosthetic aids and appliances to improve their condition. Under the scheme, training facility through workshops, camps and audio-visual aids, home management of disabled are proposed to be undertaken. Free distribution of 15 Kg. of rice to disabled persons every month for the purpose of alleviating their poverty and to feel them secured in the Society.

3. Actual Physical Achievements during Eleventh Five Year Plan (2007-12) :

- iii) Marriage incentive given to 50 beneficiaries.

- vi) Payment of Transport Allowance – 2500 persons will be benefitted.

- viii) Distribution of cooling glasses and Braille watches and walking sticks to 50 disabled persons.
- ix) Financial assistance will be given to 23,000 disabled persons
- x) Motorized tricycles will be distributed to 150 disabled persons.
- xi) Exgratia payment @ Rs.5000/- to 400 disabled persons.

1. **Name of the Scheme** : Integrated welfare programme for children
2. **Objective of the Scheme** :

The objectives of Integrated Child Protection Scheme (I.C.P.S) are to contribute to the improvements in the well living of children in difficult circumstance, as well as to the reduction of vulnerabilities to situations, action that lead to abuse, neglect, exploitation, abandonment and separation of children. These will be achieved by (i) improved access to quality of child protection services (ii) raise public awareness about the reality of child rights, situation and protection in India (iii) clearly articulated responsibilities and enforced accountability for child protection (iv) Established & functioning structures at all government levels for delivery of statutory and support services to children in difficult circumstances (v) Introduced and exceptional evidence based monitoring and evaluation. The children homes run by Government / NGOs will benefit from this scheme.

Through the Home for Visually Handicapped and Hearing Impaired, free education is provided upto 10th Standard and train them in vocal and instrumental music. It is proposed to construct staff quarters, store room, auditorium, hearing aid laboratory and workshop. Every year 10 new inmates will be admitted in each of home at Pondicherry and Karaikal. A Home for Mentally Retarded Children is functioning in Pondicherry with 25 inmates.

To provide custody, protection, treatment, development of character, education and vocational training to the children committed under the Juvenile Justice (Care and Protection of Children) Act 2000 and to provide temporary accommodation for the children in conflict with law pending any enquiry under Juvenile Justice (Care and Protection of Children) Act 2000, a separate Observation Home has to be established.
