The Revised Outlay for 2014-15 is sent herewith in the Annex enclosed. The Heads of Departments are requested to furnish the scheme-wise budgetary details for the Revised Outlay to the Budget Section of the Finance Department and scheme-wise details to this department.

- i) The allocation earmarked under CSS is only Central Share. State Share to be provided by the departments from their allocation.
- ii) Diversion of funds will not be allowed under CSS.
- iii) Authorisation already issued has to be regularised.
- iv) Excess booking if any, need to regularised.
- v) The overall outlay is inclusive of SCSP outlay.
