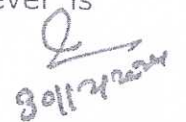

The written competitive examination for recruitment to the post of Investigator in the Planning and Research Department, Puducherry was held on 29-12-2024.

Based on the marks obtained in the competitive examination held on 29-12-2024, the category wise merit list of candidates provisionally selected to the post of Investigator is given in the **Annexure-I**. Also, the category-wise wait list is given in the **Annexure-II**.

The wait list shall be operated in the event of occurrence of a vacancy in the select list of Investigator due to non-appearance for certificate verification, non-joining of the candidate within the stipulated time allowed for joining the post or when a candidate joins but resigns or expires within a period of one year from the date of joining or the fresh recruitment is conducted, whichever is earlier.

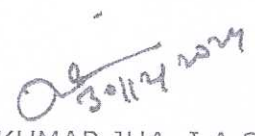
